thence, North 0 degrees 25 minutes 05 seconds East, a distance of 579.70 feet to an iron pin found on the South side of the aforementioned Right-of-Way, said point being the POINT OF BEGINNING:

thence, following said Right-of-Way, North 78 degrees 20 minutes 46 seconds West, a distance of 495.83 feet to an iron pin found; thence, North 78 degrees 15 minutes 23 seconds West, a distance of 892.03 feet to an iron pin set;

thence, leaving said South side, North 11 degrees 44 minutes 37 seconds East, a distance of 100.00 feet to an iron pin set on the North side of said Right-of Way;

thence, following said North side of said Right of way, South 78 degrees 15 minutes 23 seconds East, a distance of 790.25 feet to an iron pin set;

thence, South 78 degrees 20 minutes 46 seconds East, a distance of 576.57 feet to an iron pin found;

thence, South 77 degrees 57 minutes 37 seconds East, a distance of 583.96 feet to a Railroad Spike set in Athens Township Road

thence, leaving said Right-of Way and following said road, South 37 degrees 25 minutes 03 seconds West, a distance of 55.55 feet to a Railroad Spike set:


