## DESCRIPTION OF SURVEY FOR PAMELA J. FARLEY

Being a part of a 10.00 acre± tract of land transferred to Pamela J. Farley as recorded in Official Records Volume 78 at page 389, Athens County Recorder's office. Athens County, Ohio, also being a part of Lease Lot No's 107 and 140, Sections 23 and 29, Township-9-North, Range-14-West, Athens Township, Athens County, State of Ohio and more particularly described as follows:

Beginning at a 5/8" iron pin set on the east line of said Section 29 which is assumed to bear North 11°27'21" East a distance of 334.78 feet from the Southeast corner of said Lease Lot No. 140:

Thence leaving said Section line South 30° 17'08" West passing thru a 5/8" iron pin set at a distance of 177.00 feet and going a total distance of 178.72 feet to a point;

Thence North 59°02'39" West a distance of 231.29 feet to a point;

Thence North 53°12'37" East passing thru 5/8" iron pins set at a distance of 0.38 feet and at a distance of 403.41 feet and going a total distance of 421.41 feet to a point in the centerline of Township Road #245;

Thence along said centerline the following two courses:

- 1. South 13°07'48" East a distance of 63.29 feet to a point;
- 2. South 37°31'11" East a distance of 25.52 feet to a point;

Thence leaving said centerline South 30°17'08" West passing thru a 5/8" iron pin set at a distance of 14.83 feet and going a total distance of 156.50 feet to the principal point of beginning containing 0.1252 acres± in said Lease Lot No. 107, Section 23 and 1.1609 acres± in said Lease Lot No. 140, Section 29 for a total of 1.2861 acres± subject to all legal easements and rights-of-way.

Bearings were derived from magnetic taken July 19, 1996.
