Situate in F.L. 111 and F.L. 113, Section 24, Town 9, Range 14, The Plains, Athens Township, Athens County, State of Onio and being more particularly described as follows:

Being all of Lot No. 226, Lot 227, and Lot 228 in the "Michael's Third Addition to Verity" (10-29-1906), except 55.11; feet off of the East end of the above said three (3) lots, and being further described as follows:

Commencing at an iron pin found in the Southwest corner of said Lot No. 228, said iron pin found being in the East Right-Of-Way line of State Route No. 682, in the North Right-Of-Way of a 10.0 alley and also being the real point of beginning of the parcel herein described: Thence N 19°22'35" % along the said East Right-Of-Way line of State Route No. 682 and the West line of Lot 228, then Lot 227, then Lot 226, 161.25 feet to an iron pipe set in the South Right-Of-Way line of First Street, said iron pipe set also being in the Northwest corner of said Lot 226, said iron pipe set also bearing S 19°22'35" E, 53.22 feet from an iron pipe found in the Southwest corner of Lot No. 106 and in the North Right-Of-Way line of said First Street; thence N 90°00'00" E along the North line of said Lot No. 226 and the South line of said Pirst Street Right-Of-Way line, 151.93 feet to an iron pipe set that bears N 90°00'00" W, 55.14 feet from an iron pin found in the Northeast corner of said Lot No. 226; thence S 00°29'05" E along a line that is West of, and parallel to, the East lines of said Lot No. 226, then Lot No. 227, then Lot No. 228, 152.12 feet to an iron pipe set in the South line of said Lot No. 228 and the North line of said 10.0' alley, said iron pipe set bearing N 90°00'00" W. 55.14 feet from a 1" iron pipe found in the Southeast corner of said Lot No. 228, passing through an iron pipe set at 75.43 feet that bears N 90° W, 9.0 feet from the Southwest corner of an existing concrete block warehouse; thence N 90°00'00" W along the South line of said Lot No. 228 and the North line of said 10.0' alley, 99.72 feet to the point of beginning and containing 0.439 acre (19,139.766 square feet), leaving 0.192 acre (8,387.596 square feet) in the above said excepted Easterly 55.14 feet of said lots 228, 227 and 226.
