Thence S 58°29'10" W along the Easterly line of said Lot No. 1, 4.80 feet to an iron pin found in the Southwesterly corner of said Lot No. 1; thence N 01°37'00" E along a random line, 74.28 feet to an iron pipe set in the Northerly line of said Lot No. 1 and the Southerly line of ~~Hedgmeadow Lane~~ in said subdivision; thence S 72°35'00" E along the said Northerly line of said Lot No. 1 and the said Southerly line of said Longmeadow Lane, 82.51 feet to the point of beginning and containing 0.0676 acres.

Subject to all legal highways and easements of record.




