## Description of survey for Charles L. Scott Tract Two

Being a part of a tract of land transferred to Charles L. and Martha R. Scott as recorded in Official Records Volume 41 at page 579 Athens County Recorder's Office, Athens County, Ohio, also being a part of Lease Lots 128, 129, 130 and 132, Section 27, Township-9, Range-14, Athens Township, Athens County, State of Ohio and more particularly described as follows;

Beginning at an existing iron pin being the southwest corner of a 4.6759 acre tract transferred to Thomas and Katherine Scott as recorded in Official Records Volume 381 at page 1201 which bears North 89°38'10" West a distance of 203.00 feet from a stone assumed to be the northeast corner of Lease Lot 127, T-9, R-14;

Thence along the assumed south line of Lease Lot 129 and along the north line of a 4.03 acre tract transferred to Deslar Malone as recorded in Official records Volume 346 at page 255 North 88°49'25" West passing thru the northwest corner of said 4.03 acre tract and continuing along the north line of a 7.14 acre tract transferred to Ann Cunningham as recorded in Official Records Volume 371 at page 949 going a total distance of 422.26 feet to an existing iron pin;

Thence continuing along the south line of said Lease Lot 129 leaving said 7.14 acre tract and along the north line of a 4.97 acre tract transferred to Stephen McKinley as recorded in Official 313 at page 307 North 89°04'31" West passing thru an existing iron pin being the northwest corner of said 4.97 acre tract at a distance of 511.84 feet and continuing along the north line of a 40.84 acre tract transferred to Robert Smith as recorded in Deed Book 354 at page 535 going a total distance of 792.87 feet to a 5/8" iron pin set;

Thence leaving the south line of said Lease Lot 129 and along the east boundary of a tract transferred to Roger Lonas as recorded in Deed Book 335 at page 351 the flowing three courses;

- 1. North 00°15'43" East a distance of 811.22 feet to a 5/8" iron pin set;
- 2. South 89°56'55" West a distance of 163.21 feet to an existing stone;
- 3. North 09°45'23" East a distance of 795.02 feet to an existing iron pin being the southeast corner of a 7.498 acre tract transferred to Kyle Lonas as recorded in Official records Volume 292 at page 2689;

Thence along the east line of said 7.498 acre tract North 00°32'07" West passing thru an existing iron pin being the northeast corner of said 7.498 acre tract and continuing along the east lien of a tract transferred to Roger Lonas as recorded in deed Book 335 at page 351 going a total distance of 798.32 feet to an existing stone being a point on

the south line of a tract transferred to Columbus and Southern Ohio Electric Company as recorded in Deed Book 202 at page 203;

Thence leaving said east line and along said south line South 88°56'42" East a distance of 46.16 feet to a 5/8" iron pin set;

Thence leaving said south line and thru the lands of the grantor the following two courses;

- 1. South 41°54'28" East a distance of 2285.32 feet to a 5/8" iron pin set;
- 2. South 81°12'54" East a distance of 211.20 feet to a 5/8" iron pin set on the boundary of a 9.8493 acre tract transferred to Charles L. Scott as recorded in Official records Volume 377 at page 269;

Thence thru the lands of said 9.8493 acre tract the following nine courses;

- 1. South 10°31'03" East a distance of 116.62 feet to a 5/8" iron pin set;
- 2. South 37°19'15" East a distance of 107.42 feet to a 5/8" iron pin set;
- 3. South 11°11'21" West a distance of 58.62 feet to a 5/8" iron pin set;
- 4. South 02°49'29" East a distance of 51.66 feet to a 5/8" iron pin set;
- 5. South 17°34'02" East a distance of 65.15 feet to a 5/8" iron pin set;
- 6. South 54°09'21" East a distance of 65.91 feet to a 5/8" iron pin set;
- 7. South 17°09'59" East a distance of 51.37 feet to a 5/8" iron pin set;
- 8. South 41°29'02" East a distance of 120.27 feet to a 5/8" iron pin set;
- 9. South 30°46'30" East passing thru a 5/8" iron pin set at a distance of 59.93 feet and going a total distance of 89.93 feet to a point in the centerline of Twonship Road 241, Lavelle Road;

Thence along said centerline the following two courses;

- 1. South 66°53'55" West a distance of 107.85 feet to a point;
- 2. South 60°48'50" West a distance of 52.21 feet to a point being the southeast corner of a 1.56 acre tract transferred to Robert Cowie as recorded in Official Records Volume 381 at page 1204;

Thence leaving said centerline and along the east line of said 1.56 acre tract the following two courses;

- 1. North 09°43'44" West passing thru an existing iron pin at a distance of 15.17 feet and going a total distance of 131.31 feet to an existing iron pin;
- 2. North 33°51'12" West a distance of 242.56 feet to an existing iron pin being the northeast corner of said 1.56 acre tract;

Thence leaving said 1.56 acre tract and along the east line of a tract transferred to Thomas and Katherine Scott as recorded in Deed Book 358 at page 353 North 33°51'12" West a distance of 218.26 feet to an existing iron pin being a point on the boundary of a 4.6759 acre tract transferred to Thomas and Katherine Scott as recorded

Thence along the boundary of said 4.6759 acre tract the following six courses;

- 1. North 35°59'03" East a distance of 138.38 feet to an existing iron pin;
- 2. North 76°07'56" West passing thru existing iron pins at a distance of 131.15 feet and at a distance of 378.18 feet and going a total distance of 419.93 feet to a point:
- 3. South 49°08'17" West a distance of 95.00 feet to a point;
- 4. South 22°37'26" West passing thru existing iron pins at a distance of 20.00 feet and at a distance of 120.71 feet and going a total distance of 140.71 feet to a point:
- 5. South 17°01'25" West a distance of 131.28 feet to an existing iron pin;
- 6. South 12°43'03" East a distance of 403.39 feet to the principal point of beginning containing 27.1246 acres more or less in said Lease Lot 129 and 26.6876 acres more or less in said Lease Lot 130 for a total of 53.8122 acres more or less subject to all legal easements and rights of way.

Bearings are assumed and are for the determination of angles only.

All iron pins set are 5/8"X30" rebar with plastic ID cap stamped "CTS-6844".
