Situated in Lease Lot 213 , Section 3, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at a found iron pin\* (5/8" rebar) at the southeast corner of said Lease Lot 213 ; thence on an assumed bearing

North 67°17'16" West a distance of 1057.06 feet

to a point in Athens Township Road 134 (Phillips Lane) on the west line of Frank and Pamela Solich (385-216 O.R.) THE TRUE POINT OF BEGINNING; thence along said road and said west line of Solich (385-216 O.R.) the following eleven bearings and distances:

North 00°32'32" West a distance of 75.08 feet to a point ; thence North 08°40'56" East a distance of 40.28 feet to a point ; thence North 01°13'59" West a distance of 21.39 feet to a point ; thence North 20°01'13" West a distance of 36.41 feet to a point ; thence North 33°24'22" West a distance of 31.27 feet to a point ; thence North 40°23'39" West a distance of 55.24 feet to a point; thence North 34°40'42" West a distance of 40.38 feet to a point; thence North 31°30'17" West a distance of 67.29 feet to a point; thence North 30°32'47" West a distance of 163.14 feet to a point ; thence North 31°46'14" West a distance of 125.87 feet to a point ; thence North 29°05'02" West a distance of 91.93 feet to a point ; thence leaving said road along a new line the following five bearings and distances: North 73°19'39" East a distance of 533.25 feet (passing through a set iron pin at 11.12 feet) to a set iron pin; thence South 80°09'46" East a distance of 501.42 feet to a set iron pin ; thence South 35°13'22" East a distance of 302.35 feet to a set iron pin ; thence

South 09°31'02" West a distance of 268.35 feet to a set iron pin ; thence South 75°29'38" West a distance of 849.39 feet

(passing through a set iron pin at 834.39 feet) to the point of beginning and containing 14.500 acres and being part of Parcel III of the parcels of land described in Volume 385 Page 216 of the Athens County Official Deed Records. \*Note: Denotes calculated monument based on a previous survey.

Note 1) Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a yellow plastic identification marker inscribed: "TOM TRANTINA RLS-8320"

Note 2) All calls for adjoiners cited above and deeds shown in parenthesis are given to fulfill County Auditor and County Engineer's requirements and do not necessarily imply an acceptance of the content of said deeds nor the seniority of the same. 
