

- 10) Subject to all legal highways and easements.
- All iron pins w/cap set referred to in the description above are 5/8" x 30" iron pins with flourescent pink 1-3/8" O.D. plastic I.D. caps stamped "G. W. BAYHA P.S.6139 740-593-5686".
- 12) The above described "4.6485 Acre New Legal Description" was surveyed by Gerald W.
