Should the County Engineer determine to submit a statement for reimbursement, the statement shall be filed with the Board at the time the County Engineer files his written report with the Board.

ORC Section 709.031(A) provides: Within 5 days after the petition for annexation is filed with the board of county commissioners, the clerk of the board shall refer the legal description of the perimeter and the map or plat of the territory proposed to be annexed to the county engineer for a report upon the accuracy of the legal description, map or plat. Upon receiving these items, the county engineer shall file, at least 25 days before the hearing, a written report with the board based on the engineer's findings, which shall not be conclusive upon the board. Failure of the engineer to make the report shall not affect the jurisdiction or duty of the board to proceed.

A RESOLUTION INDICATING THE SERVICES THE CITY OF ATHENS WILL PROVIDE FOR THE PROPOSED ANNEXATION OF APPROXIMATELY 2.00 ACRES LOCATED AT 2 RIDGEVIEW, AS REQUESTED BY THE ANNEXATION PETITIONER; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

SECTION I: Pursuant to Ohio Revised Code Section 709.03(D), the City of Athens hereby states that, upon annexation, it will provide water and sewer services, and police and fire protection to approximately 2.00 acres, located at 2 Ridgeview, owned by Jules David Sturbois, situated in Farm or Lease Lots No. 32 and 34, Town 9, Range 14, of the Ohio River Survey and in Athens Township, Athens County, Ohio, in accordance with the description survey and map attached hereto and incorporated herein by reference.

SECTION II: This resolution is not intended to eliminate the obligation of the City to accept said proposed annexation by an appropriate ordinance if released by the Athens County Commissioners.

SECTION III: This Resolution is to be an emergency measure necessary for the preservation of the health, welfare and safety of the residents of the City of Athens in order to provide information necessary for a public hearing scheduled by the Athens County Commissioners on February 12, 2013, and that it shall be in full force and effect upon its passage and approval by the Mayor.
