Situated in Lease Lot 33, Section 7, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at a stone* on the grantor's west line at the northeast corner of northeast corner of a 15.16 acre tract described in Volume Lease Lot 36 at the 301 Page 2016 of the Athens County Official Records at the southeast corner of a 26.09 acre tract described in Volume 378 Page 401 of the Athens County Deed Records, THE TRUE POINT OF BEGINNING; thence along the grantor's west line and along the east line of said 26.09 acre tract on an assumed bearing North 04 Degrees 03 Minutes 59 Seconds East a distance of 281.43 feet to an iron pin* at the grantor's northwest corner and the southwest corner of a 5.573 acre tract described in Volume 311 Page 2348 of the Athens County Official Records; thence along the grantor's north line and the south line of said 5.573 acre tract North 89 Degrees 22 Minutes 14 Seconds East a distance of 256.89 feet to a set iron pin at the grantor's northeast corner on the west right of way line of U.S. Route 33; thence along the grantor's east line and the west right of way line of U.S. Route 33 South 09 Degrees 31 Minutes 05 Seconds East a distance of 1163.80 feet to a set iron pin; thence leaving said right of way and along a new line the following three bearings and distances: 1) South 75 Degrees 55 Minutes 05 Seconds a distance of 216.62 feet to a set iron pin; thence 2) South 87 Degrees 16 Minutes 00 Seconds West a distance of 198.78 feet to a set iron pin; thence 3) South 78 Degrees 38 Minutes 59 Seconds West a distance of 116.97 feet to a set iron pin on the grantor's west line on the east line of a 27.40 acre tract described in Volume 254 Page 55 of the Athens County Deed Records; thence along the grantor's west line and the east line of said 27.40 acre tract and the east line of aforesaid 15.16 acre tract North 03 Degrees 15 Minutes 35 Seconds East a distance of 950.98 feet to the point of beginning and containing and being a part of the First Tract of the tracts described in Volume 258 Page 72 of the Athens County Deed Records.

NOTE: THE ABOVE DESCRIBED 10.822 ACRE TRACT IS TO BE CONTINUOUS AND CONTIGUOUS WITH THE ADJOINING 26.09 ACRE TRACT DESCRIBED IN VOLUME 378 PAGE 401 OF THE ATHENS COUNTY DEED RECORDS.
