A CONTINUOUS AND CONTIGUOUS TRANSFER BETWEEN ADJOINING PROPERTY OWNERS

Situated in Lease Lot 33, Section 7, Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:

Commencing at a found limestone (broken top replaced over good base) on the grantor's west line at the northeast corner of Lease Lot 36 at the corner of a 15.16 acre tract described in Volume 301 Page 2016 of the Athens County Official Records at the southeast corner of a 26.09 acre tract described in Volume 378 Page 401 of the Athens County Deed Records, THE TRUE POINT OF BEGINNING; thence along the grantor's west line and along the east line of said 26.09 acre tract on an assumed bearing North 04 Degrees 04 Minutes 17 Seconds East a distance of 281.44 feet to a found iron pin at the grantor's northwest corner and the southwest corner of a 5.573 acre tract described in Volume 311 Page 2348 of the Athens County Official Records; thence along the grantor's north line and the south line of said 5.573 acre tract North 89 Degrees 21 Minutes 09 Seconds East a distance of 256.67 feet to a set iron pin at the grantor's northeast corner on the west right of way line of U.S. Route 33; thence along the grantor's east line and the west right of way line of U.S. Route 33 South 09 Degrees 31 Minutes 05 Seconds East a distance of 549.58 feet to a point; thence leaving said right of way and along a new line South 89 Degrees 09 Minutes 57 Seconds West passing a set iron pin at 2.11 feet, for a total distance of 382.61 feet to a set iron pin on the grantor's west line on the east line of aforesaid 15.16 acre tract; thence along the grantor's west line and the east line of said 15.16 acre tract North 03 Degrees 16 Minutes 01 Seconds East a distance of 264.38 feet to the point of beginning and containing 4.001 acres and being a part of the First Tract of the tracts described in Volume 258 Page 72 of the Athens County Deed Records.

NOTE: THE ABOVE DESCRIBED 4.001 ACRE TRACT IS TO BE CONTINUOUS AND CONTIGUOUS WITH THE ADJOINING 26.09 ACRE TRACT DESCRIBED IN VOLUME 378 PAGE 401 OF THE ATHENS COUNTY DEED RECORDS.
