Commencing at a found iron pin at the northeast corner of said Lot 3667 and the northwest corner of Lot 3666 of said LaMar Heights 3<sup>rd</sup> Addition; thence along the common line between Lot 3666 and Lot 3667 South 0 degrees 24 minutes 52 seconds West (passing a set iron pin at 70.00 feet) for a total distance of 105.00 feet to a set iron pin; thence leaving the aforesaid common boundary line North 13 degrees 13 minutes 09 seconds West, a distance of 42.42 feet to a set iron pin; thence North 0 degrees 24 minutes 52 seconds East, a distance of 65.00 feet to a set iron pin on the north line of said Lot 3667; thence along the north line of said Lot 3667 South 82 degrees 34 minutes 48 seconds East, a distance of 10.08 feet to the point of beginning and containing 0.0195 acre, and being a part of Lot 3667 of the LaMar Heights 3rd Addition as described in Volume 4 Page 195 of the Athens County Official Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


