Situated in Outlot 25 of the City of Athens, Section 9, Town 9, Range 14, Athens Township, Athens County, Ohio and described as follows:

Commencing at an iron pin* at the northeast corner of Outlot 27; thence on an assumed bearing along the east line of lands described in Volume 350 Page 149 of the Athens County Deed Records South 8 degrees 42 minutes 23 seconds West, a distance of 390.23 feet to an iron pin found at the northeast corner of a 2.48 acre tract described in Volume 359 Page 861 of the Athens County Deed Records; thence along the east line of said 2.48 acre tract South 8 degrees 41 minutes 49 seconds West, passing a found iron pin at 279.48 feet, for a total distance of 299.30 feet to a point at the southeast corner of said 2.48 acre tract, THE TRUE POINT OF BEGINNING; thence along the southerly prolongation of the east line of said 2.48 acre tract South 8 degrees 41 minutes 49 seconds West, a distance of 13.61 feet to the center of an un-named, sixty-six (66) foot platted street vacated by the City of Athens by Ordinance Number 0-20-64; thence along the centerline of said vacated street South 88 degrees 57 minutes 28 seconds West, a distance of 341.87 feet to a point at the intersection of the centerline of said vacated street with the southerly prolongation of the west line of aforesaid 2.48 acre tract; thence along the southerly prolongation of the west line of said 2.48 acre tract North 00 degrees 00 minutes West, a distance of 13.67 feet to a point at the southwest corner of said 2.48 acre tract; thence along the south line of said 2.48 acre tract North 89 degrees 00 minutes 00 seconds East, a distance of 343.92 feet to the POINT OF BEGINNING and containing 0.107 acre, and being a part of Parcel Four of the Parcels of land described in Volume 350 Page 149 of the Athens County Deed Records.

*Denotes the calculated location of a previously set iron pin in a survey by Southeastern Land Surveys for Benedict Incorporated dated February 23, 1990.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


