Being a Re-Survey of Tract 3 conveyed to SOHO Rentals, LLC, as recorded in O.R. Book 502, Page 255, in the Athens County Deed Records, and being all of Auditor's P.P.N. A02-81600054-00, and further described as follows;

Commencing at a the Southwest corner of said Lot 1975 of L.H. Clark's Addition to the City of Athens:

Thence, N 87°36'49" E 213.37 feet with the South line of said Lot 1975, to a 1.5" o.d. iron pipe found on the West line of Lot 2712 of Alderman Heights and a parcel conveyed to Sally A. Robe, as recorded in Deed Volume 317, Page 539;

Thence, N 01°08'04" W 29.50 feet with the West line of said Lot 2712 and said parcel conveyed to Robe (D.V.317,Pg.539), to a 1.5" o.d. iron pipe found on the South line of a parcel conveyed to Luar S. Romero, as recorded in O.R. Book 472, Page 1465;

Thence, N 88°36'29" E 64.47 feet with the North line of said parcel conveyed to Robe (D.V.317,Pg.539), the same being the South line of said parcel conveyed to Robero (O.R.472,Pg.145), to a 3/4" o.d. iron pipe found marking the **PRINCIPLE PLACE OF BEGINNING**, of the **0.132 Acre** parcel herein to be described;

Thence, N 48°02'41" W 122.12 feet to a 5/8" o.d. iron pin found in Woodward Avenue (50' Wide R/W);

Thence, N 38°06'38" E 39.99 feet in Woodward Avenue, to a 5/8" o.d. iron pin found;

Thence, S 47°40'09" E 168.84 feet leaving Woodward Avenue with the West line of a parcel conveyed to Demetros Prokos, as recorded in O.R. Book 41, Page 852, to a 1" o.d. iron pipe found on the North line of said parcel conveyed to Robe (D.V. 317, Paeg 539), also being on the North line of said Lot 2712;
