Being a Re-Survey of PARCEL THREE conveyed to The Eleanor Barstow Living Trust, as recorded in O.R. Book 436, Pages 813-818, in the Athens County Deed Records, and being all of Auditor's P.P.N. A02826000500, and further described as follows;

Commencing at an iron pin set on the West Right of Way line of East State Street (66' Wide) marking the Southeast corner of Inlot 120, also being on the North line of an alley, and being the **PRINCIPLE PLACE OF BEGINNING** of the 0.107 Acre parcel herein to be described;

Thence, N 62°29'01" W 111.57 feet leaving East State Street with the North line of said alley, the same being the South line of said Inlot 120, to an iron pin set at the base of a concrete & brick retaining wall, being the Southeast corner of a parcel conveyed to Kam Ping Lam, as recorded in O.R. Book 256, Page 541;

Thence, N 28°31'58" E 41.56 feet leaving said alley along the base of said retaining wall, the same being the East line of said parcel conveyed to Kam Ping Lam, to an iron pin set on the South line of a parcel conveyed to Donald F. & Deborah E. Smith, as recorded in O.R. Book 57, Page 1184;

Thence, S 62°40'03" E 110.90 feet with the South line of said parcel conveyed to Smith and extending along the South line of a parcel conveyed to Linda M. Scott, as recorded in O.R. Book 171, Page 192, to a 3/4" o.d. iron pipe found on the West line of East State Street marking the Southeast corner thereof, also being on the East line of said Inlot 120, and passing over a 3/4" o.d. iron pipe found marking the Southwest corner of said parcel conveyed to Scott at 20.99 feet;


Thence, S 27°36'00" W 41.91 feet with the West Right of Way Line of East State Street, the same being the East line of said Inlot 120, to the **PRINCIPLE PLACE OF BEGINNING**, and containing 0.107 Acres, more or less, and is subject to all legal easements, right of ways, zoning ordinances, and restrictions of record.

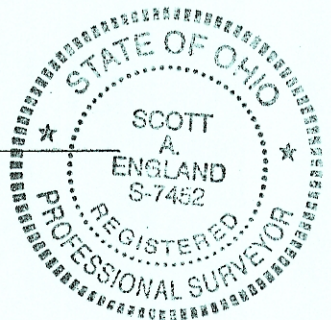

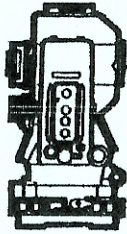

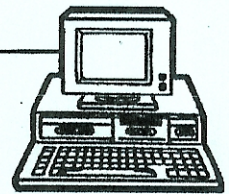

Commencing at an iron pin set on the West Right of Way line of East State Street (66' Wide) marking the Southeast corner of Inlot 118, also being the Northeast corner of Inlot 116, being the Northeast corner of a parcel conveyed to Edna Brooks Foundation, as recorded in Volume 35, Page 788, and being the PRINCIPLE PLACE OF BEGINNING of the 0.184 Acre parcel herein to be described;

Thence, N 62°37'32" W 110.30 feet leaving East State Street with the line between said Inlot 118 and Inlot 116, the same being the North line of said parcel conveyed to Edna Brooks Foundation, to a 3/4" o.d. iron pipe found marking the Southeast corner of a parcel conveyed to Martha Young McVey, as recorded in O.R. Book 349, Page 378;

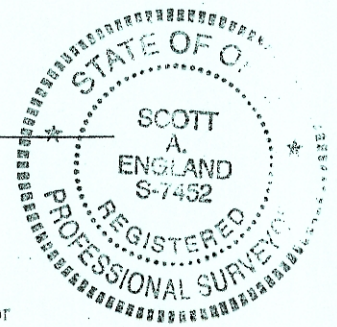

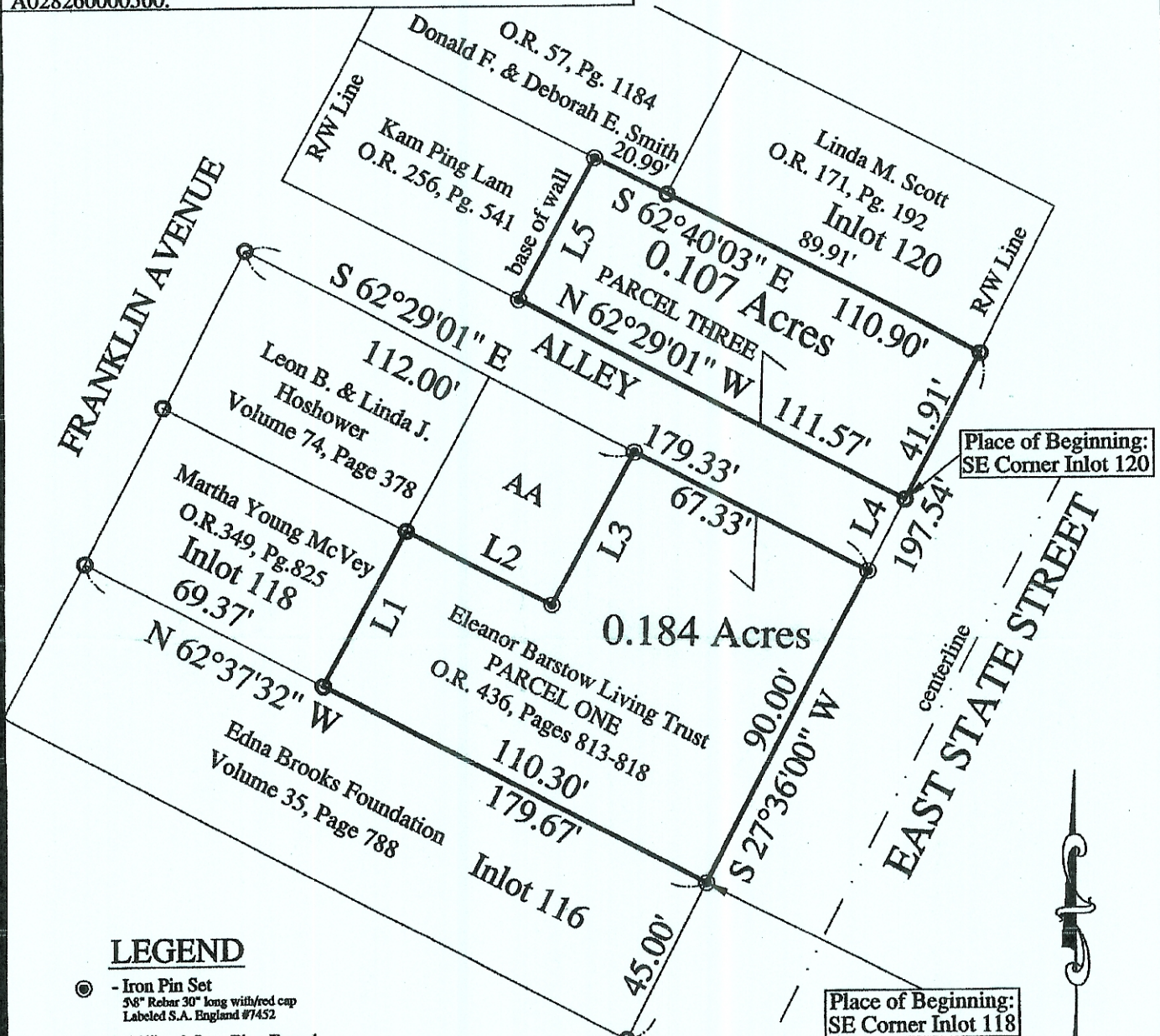

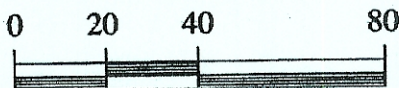
