## DESCRIPTION

BEING A SURVEY TO COMBINE A PART OF TWO SEPARATE PARCELS INTO ONE PARCEL FOR THE OHIO UNIVERSITY, TO BE KNOWN AS TRACT "OUCOM",

Situated in and being a Part of Lease Lot 59 and Lease Lot 61, in Section 15, Township 9 North, Range 14 West, in the City of Athens, Athens Township, Athens County, Ohio, and being a Part of the Ohio University Tract, also known as Parcel No.A029050100100, Currently Carried as 24.23 Acres, as Recorded in Official Record 141, Page 870, and a Part of the State of Ohio (Ohio University) Tract, also known as Parcel No.A029050103000, Currently Carried as 101.48 Acres, as Recorded in Volume 67, Page 407, both being in the Athens County Recorder's Office, Athens County, Ohio,

The Point of Commencement being at the Northwest Corner of Lease Lot 59, being the Intersection of Lease Lots 59, 60 and 61. (Note: This was not located as Part of this project. This is referenced in a previous survey by Gregory Wright P.S.6535, dated August of 1989), with a tie line, South 01 degrees 48 minutes 34 seconds East for a distance of 34.66 feet, to a Set 5/8" X 30" Rebar with a Plastic ID. Cap Stamped T.G. Smith/S-8051, being the Northwest Corner of and the True Point of Beginning of the Newly Created Tract "OUCOM", (N=481356.048, E=2077733.621),

Leaving the Northwest Corner of the Newly Created Tract "OUCOM", and running with and along a New Line of Division through the State of Ohio (Ohio University) Tract, and a West Line of the Newly Created Tract "OUCOM", THENCE North 34 degrees 06 minutes 55 seconds East, passing out of Lease Lot 59 and into Lease Lot 61, for a total distance of 234.39 feet, to a Found 1" Iron Pipe Capped EMHT,

Continuing to run with and along a New Line of Division through the State of Ohio (Ohio University) Tract, and a West Line of the Newly Created Tract "OUCOM", THENCE North 36 degrees 17 minutes 59 seconds East for a distance of 780.18 feet, to a Set 5/8" X 30" Rebar with a Plastic ID. Ridge Drive, (Note: not dedicated as a road or street at this time), and the South Line of the Ohio University 24.23 Acre Tract, THENCE South 66 degrees 21 minutes 41 seconds West for a distance of 62.49 feet, to a Found 5/8" Rebar with No ID. Cap, being a Common Corner of the Newly Created Tract "OUCOM", and the City of Athens' Tract,

Continuing to run with and along a New Line of Division through the State of Ohio (Ohio University) 101.48 Acre Tract, and the West Line of the Newly Created Tract "OUCOM", and the East Line of the City of Athens' 1.0441 Acre Tract, (S. Park Drive), THENCE North 12 degrees 54 minutes 58 seconds West for a distance of 121.82 feet, to a Set 5/8" X 30" Rebar with a Plastic ID. Cap Stamped T.G. Smith/S-8051,
