LEGAL DESCRIPTION

WITH CORRECTIONS MADE TO THE QUIT CLAIM DEED DESCRIBED IN VOLUME 390 PAGE 2584 OF THE ATHENS COUNTY OFFICAL DEED RECORDS

The following legal description was based on a new retracement survey utilizing currently existing monuments found that provide a more accurate description of the two tracts and one exception tract in the Quit Claim Deed to Brian and Rebeka Muhn, Trustees of the Muhn Family Trust (created December 14, 2005) described in Volume 390 Page 2584 of the Athens County Official Deed Records. Based on monuments found, new monuments were placed at all corners where they are missing. This was done to meet Athens County Standards required for future transfer of property. Encroachments found in the course of the survey are also illustrated on the survey plat.

Situated in Inlots 153 and 154 of the City of Athens, Section 16 Athens Township, Town 9, Range 14, Athens County, Ohio and described as follows:
