Thence with the east line of Lot 84, North 28 degrees 25 minutes 21 seconds East a distance of 212.95 feet to a 5/8" iron pin set on the south right of way line of Broadmoor Court; Thence with the south line of Broadmoor Court along a curve to the right with the delta angle of 19 degrees 22 minutes 08 seconds, a radius of 100.00 feet, a length of 33.81 feet, and a chord of which bears South 28 degrees 41 minutes 57 seconds East a distance of 33.64 feet to a 5/8" iron pin set;

Thence with the south line of Broadmoor Court along a curve to the left with the delta angle of 19 degrees 28 minutes 24 seconds, a radius of 76.50 feet, a length of 26.00 feet, and a chord of which bears South 28 degrees 45 minutes 08 seconds East a distance of 25.88 feet to a 5/8" iron pin set on the northwest right of way of University Estates Boulevard (60'R/W);

Thence with the northwest right of way of University Estates Boulevard (60'R/W), South 28 degrees 25 minutes 21 seconds West a distance of 222.78 feet to a 5/8" iron pin found at the Northeast corner of Lot 56A University Estates Subdivision, Phase I;

Thence with the northeast line of Lot 56A, North 54 degrees 27 minutes 50 seconds West a distance of 111.63 feet to a 5/8" iron pin found at the north corner of Lot 56A;

Thence with the southeast line of Lot 85 University Estates Subdivision, Phase II, North 58 degrees 59 minutes 14 seconds East a distance of 59.39 feet to a 5/8" iron pin found at the east corner of Lot 85;

Thence with the west line of Lot 84, South 24 degrees 48 minutes 33 seconds East a distance of 38.16 feet to the point of beginning and containing 0.322 acres, more or less, subject to any public or private easements of record.


