Situated in the City of Athens, County of Athens, State of Ohio, and being a part of Farm Lot 27 in Section 4, Township 9N, Range 14W, of the Ohio Company's Purchase, and being more being more particularly described as follows;

Being a Survey of a part of a parcel conveyed to The City of Athens, as recorded in Deed Book 212, Page 1, in the Athens County Deed Records, also being part of Auditor's P.P.N. A027380001900, and further described as follows;

Commencing at for reference at the Northwest corner of Farmlot 27;

Thence, S 03°02'36" W 3541.31 feet with the West line of Farmlot 27, to a 5/8" o.d. iron pin found marking the Northwest corner of said parcel conveyed to The City of Athens (DB212,Pg1) of which this description is a part, also being the Southwest corner of a 2.725 Acre parcel conveyed to Ohio University Athens Public Library, as recorded in O.R. Book 129, Page 854, being on the East Right of Way Line of Home Street (60' Wide R/W)(undeveloped), and being the **PRINCIPLE PLACE OF BEGINNING** of the **0.395 Acre** parcel herein to be described;

Thence, N 81°14'56" E 572.82 feet with the North line of said parcel conveyed to The City of Athens (DB212,Pg1), of which this description is a part, the same being the South line of said parcel conveyed to Ohio University Athens Public Library (OR129,Pg854), to a 5/8" o.d. iron pin found on the West Limited Access Right of Way Line of U.S. Route 33;

Thence, S 00°03'21" E 30.35 feet with the West Limited Access Right of Way Line of U.S. Route 33 across said parcel conveyed to The City of Athens (DB212,Pg1), of which this description is a part, to a 5/8" o.d. iron pin found on the South line thereof, and being on the North line of a 14.91 Acre parcel conveyed to Ohio University, as recorded in O.R. Book 109, Page 215;

Thence, S 81°14'56" W 574.50 feet with the South line of said parcel conveyed to The City of Athens (DB212,Pg1), of which this description is a part, the same being the North line of said parcel conveyed to Ohio University (OR109,Pg215), to a 5/8" o.d. iron pin found marking the Southeast corner of said Home Street;

Thence, N 03°02'36" E 30.65 feet with the West line of said parcel conveyed to The City of Athens (DB212,Pg1), of which this description is a part, the same being the East Right of Way Line of said Home Street, to the **PRINCIPLE PLACE OF BEGINNING**, and containing **0.395 Acres**, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

All iron pins set are 5/8" o.d. iron pins 30" long with red caps labeled "S.A. ENGLAND #S-7452".



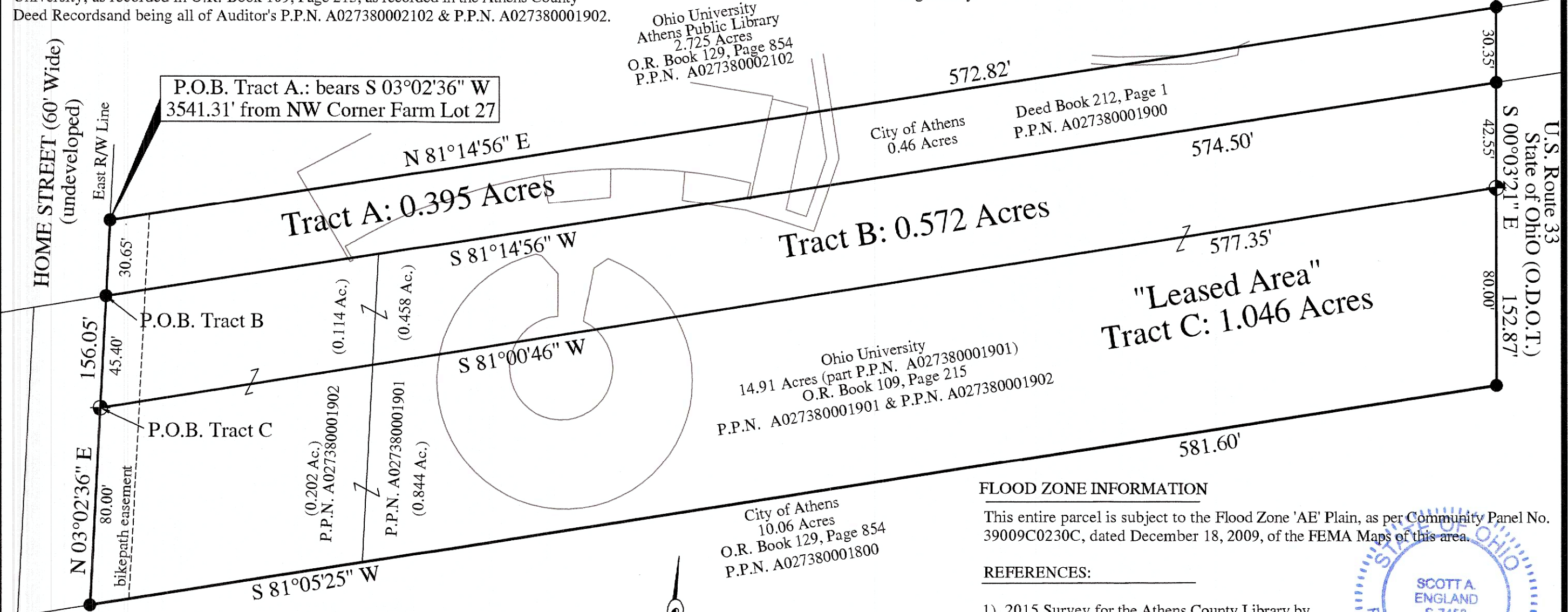

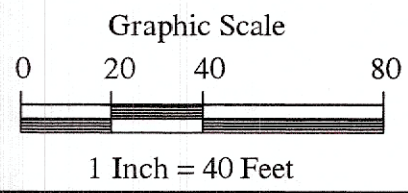
