Being a Survey of Parcel 6 conveyed to Barbara J. Good, Trustee, as recorded in O.R. Book 393, Page 236, in the Athens County Deed Records, and being all of Auditor's P.P.N. A02-71000041-00, and further described as follows;

Commencing at a mag nail found marking the Southeast corner of Inlot 28 and a parcel conveyed to 19 West State, LLC, as recorded in O.R. Book 495, Page 704, also being the Northeast corner Inlot 30 and a parcel conveyed to Wharton Rentals, LLC, as recorded in OR. Book 566, Page 833,;

Thence, N 85°51'08" W 81.40 feet with the South line of said Inlot 28 and said parcel conveyed to 19 West State (OR495,Pg.704), the same being the North line of said parcel conveyed to Wharton Rentals, LLC (OR566,Pg833), to a mag nail found;

Thence, N 03°05'41" E 7.85 feet with the East line of said parcel conveyed to Wharton Rentals, LLC (OR566,Pg.833), the same being the West line of said parcel conveyed to 19 West State, LLC (OR495,Pg704) to a mag nail found, and being the PRINCIPLE PLACE OF BEGINNING of the 0.049 Acre parcel herein to be described;

Thence, N 03°05'41" E 126.16 feet continuing with the East line of said parcel conveyed to Wharton Rentals, LLC (OR495,Pg704) and extending along the East line of a parcel conveyed to Peter L.
