# Legal Description 5.077 Acres Part Edgart, Ltd. Parcel: O.R. Book 406, Page 333

Situated in the Township of Athens, County of Athens, State of Ohio, and being part of Lease Lot 8 in Section 1, Township 9N, Range 14W, of the Ohio Company's Purchase, and being more particularly described as follows;

Being a Survey of a part of a parcel conveyed to Edgart, Ltd., as recorded in O.R. Book 406, Page 333, in the Athens County Deed Records, and being part of Auditor's P.P.N. A01-00100176-00, and further described as follows;

Commencing at a 5/8" o.d. iron pin found capped "Swoyer" marking the Northeast corner of Lot 1 of Old Coach Highland Subdivision, as recorded in Plat Envelope 438-A, in the Athens County Plat Records, being on the West line of an 80.470 Acre parcel conveyed to May L.M. Bonnaud, as recorded in O.R. Book 612, Page 579, and being the **PRINCIPLE PLACE OF BEGINNING** of the **5.010 Acre** parcel herein to be described;

Thence, S 72°12'26" W 96.23 feet with the North line of said Lot 1, to a 5/8" o.d. iron pin found capped "Swoyer" on the East Right of Way Line of Old Coach Road (50' Wide R/W);

Thence, with the Right of Way Line of the cul-de-sac of Old Coach Road with curve to the right (Radius = 50.00 feet, Delta Angle 240°02'21", Arc Length 209.53 feet) with a chord bearing S 65°25'39" W 86.61 feet to a 5/8" o.d. iron pin found capped "Swoyer" on the West line of Lease Lot 8, and being on the East line of Lease Lot 7 and a 5.22 Acre parcel conveyed to David J. Kaufman, as recorded in O.R. Book 367, Page 1636;

Thence, N 05°25'03" E 259.53 feet with the West line of Lot 8 and said parcel conveyed to Edgart. Inc., also being the East line of Lease Lot 7 and said parcel conveyed to Kaufman, and extending across Old Coach Road, to an iron pin set on the East Right of Way thereof, and being the Southeast corner of a 3.15 Acre parcel conveyed to Julia A. Sparhawk, ETAL, as recorded in O.R. Book 514, Page 194, and Lease Lot 7, and passing over an iron pin set on the West Right of Way Line of Old Coach Road at 176.65 feet;

Thence, N 05°24'21" E 641.42 feet with the West line of said parcel conveyed to Edgart, Ltd., and Lease Lot 8, the same being the East line of said parcel conveyed to Sparhawk, ETAL and Lease Lot 7, to an iron pin set on the North line of Edgart, Ltd. & Lease Lot 8, the same being the South line of Lease Lot 10 in Section 2 and a 10.827 Acre parcel conveyed to University Rentals 3, LLC, as recorded in O.R. Book 546, Page 777;

Thence, S 85°12'51" E 336.88 feet with the North line of said parcel conveyed to Edgart, Ltd. & Lease Lot 8 in Section 1, the same being the South line of Lease Lot 10 in Section 2 and said 10.827 Acre parcel conveyed to University Rentals 3, LLC, and extending along the South line of Lease Lot 9 and an 81.96 Acre parcel conveyed to Bernard B. & Carol L. Grueser, as recorded in O.R. Book 37, Page 276, to an iron pin set on the West line of said parcel conveyed to Bonnaud;

Thence with the West line of said parcel conveyed to Bonnaud, with the following courses and distances:

- 1) S 12°50'34" W 622.78 feet to an iron pin set;
- 2) S 29°40'40" W 225.84 feet to the PRINCIPLE PLACE OF BEGINNING/

**EXCEPTING THE RIGHT OF WAY FOR OLD COACH ROAD**, as recorded on the Plat of Old Coach Road Highland Subdivision, as recoded in Plat Envelope 438A, and being more particularly described as follows;

Commencing at a 5/8" o.d. iron pin found capped "Swoyer" marking the Northeast corner of Lot 1 of Old Coach Highland Subdivision, as recorded in Plat Envelope 438-A, in the Athens County Plat Records, being on the West line of an 80.470 Acre parcel conveyed to May L.M. Bonnaud, as recorded in O.R. Book 612, Page 579, and being the Southeast corner of said parcel conveyed to Edgart, Ltd.;

Thence, S 72°12'26" W 96.23 feet with the North line of said Lot 1, to a 5/8" o.d. iron pin found on the East Right of Way of Old Coach Road, and being the **PRINCIPLE PLACE OF BEGINNING** of the **EXCEPTION** herein to be described;

Thence with the East Right of Way Line of Old Coach Road across said parcel conveyed to Edgart, Ltd., with the following three (3) courses and distances:

- 1) with a curve to the right (Radius = 50.00 feet, Delta Angle 300°01'03", Arc Length 261.88 feet) with a chord bearing **N 84°34'56" W 50.00 feet** to a 5/8" o.d. iron pin found capped "Swoyer" at a point of tangency;
- 2) N 05°25'00" E 43.21 feet to an iron pin set at a point of curvature;
- 3) with a curve to the left (Radius = 175.00 feet, Delta Angle 31°00'08", Arc Length 94.71 feet) with a chord bearing N 10°05'21" W 93.55 feet to an iron pin set at on the West line of Lot 8, also being the East line of Lot 7 and a 5.22 Acre parcel conveyed to David J. Kaufman, as recorded in O.R. Book 367, Page 1636;

Thence, N 05°25'03" E 82.88 feet with the West line of Lot 8, the same being the East line of Lot 7 extending across Old Coach Road, to an iron pin set on the East line thereof, and being the Southeast corner of a 3.15 Acre parcel conveyed to Julia A. Sparhawk, ETAL, as recorded in O.R. Book 514, Page 194;

Thence with the East Right of Way Line of Old Coach Road across said parcel conveyed to Edgart, Ltd., with the following three (3) courses and distances:

- 1) S 32°21'44" E 59.10 feet to an iron pin set;
- 2) with a curve to the right (Radius = 225.00 feet, Delta Angle 34°09'09", Arc Length 134.12 feet) with a chord bearing S 11°39'22" E 132.14 feet to an iron pin set at a point of tangency;
- 3) S 05°25'00" W 43.21 feet to the PRINCIPLE PLACE OF BEGINNING.

Said EXCEPTION contains 0.391 Acres, more or less, leaving a balance of **5.077 Acres**, more or less, and is subject to all legal easements, right of ways, and zoning restrictions of record.

Subject to the rights, restrictions, and easements of Old Coach Highland Subdivision, as recorded in Plat Envelope 438-A, as recorded in the Athens County Plat Records.


