Description of survey for Russell Chamberlain Tract "B"

Being a part of a tract of land transferred to Margaret's Creek, LLC as recorded in Official Records Volume 495 page 2672 and a 25.4104 acre tract transferred to Richard and Elizabeth Chamberlain as recorded in Official Records Volume 545 at page 2268 Athens County Recorder's Office, Athens County, Ohio, and also being all of Farm Lot 88 and a part Farm Lots 86, 91 and 92, Sections 19 and 20, Township-9, Range-14, Athens Township, Athens County, State of Ohio and more particularly described as follows:

Beginning at a stone being the southwest corner of Farm Lot 88, Section 20, T-9, R-14;

Thence along the east line of Farm Lot 86, being the west line of a tract transferred to James T. and Elaine Wetzel as recorded in Official Records Volume 343 at page 423 South00°00'00"West, a distance of 1681.78 feet to an existing iron pin being the southeast corner of said 25.4104 acre tract recorded in Official Records Volume 545 at page 2268;
