DESCRIPTION OF SURVEY FOR SARAH BRICKLES

Being a tract of land transferred to James C. and Sarah Brickles as recorded in Deed Book 344 at Page 373, Athens County Recorder's Office, Athens County Ohio, also being a part of Lot 102, Section 22, Township-9-North, Range-14-West, Athens Township Athens County, State of Ohio and more particularly described as follows:

Beginning at a point being the intersection of the centerline of State Route #682 and the North line of said Lot 102 which bears South 85°45'00" East a distance of 41.58 feet from an existing iron pin being the Southwest corner of Lot 194 and is assumed to bear South 85°45'00" East a distance of 547.14 feet from the Northwest corner of said Lot 102, Section 22, Township-9, Range-14;

Thence along said centerline South 28°45'00" East a distance of 107.91 feet to a point;

Thence leaving said centerline North 85°45'00" West passing thru a 5/8" iron pin set at a distance of 30.00 feet and going a total distance of 181.50 feet to a 5/8" iron pin set;

Thence South 27°36"25" West passing thru a 5/8" iron pin set at a distance of 50.00 feet and going a total distance of 64.02 feet to a point along Little Factory Creek;

Thence along said creek North 22°49'14" West a distance of 167.64 feet to a point on the North line of said Lot 102;

Thence leaving said creek and along said North line South 85°45'00" East passing thru a 5/8" iron pin set at a distance of 32.82 feet and thru an existing iron pin at a distance of 182.82 feet and going a total distance of 224.40 feet to the principal point of beginning containing 0.517 acre± subject to all legal easements and rights-of-way.

Bearings are assumed and are for the determination of angles only.


