Situated in the Township of Athens, County of Athens, State of Ohio, and being a part of Lease Lot 118 in Section 25, Township 9N, Range 14W, and being more particularly described as follows;

Being a Survey of Tract Two conveyed to James W. Conrath, as recorded in O.R. Book 553, Page 1809, in the Athens County Deed Records, also being part of Auditor's P.P.N. A0100100407-00, and further described as follows;

Commencing at a ¾" o.d. iron pipe found marking the Northwest corner of Carl Conrath Subdivision, as recorded in Plat Envelope 480-A, in the Athens County Plat Records, also being the Southwest corner of a parcel conveyed to Mary Lou Ramsey, as recorded in O.R. Book 421, page 1073, and being the PRINCIPLE PLACE OF BEGINNING of the 48.795 Acre parcel herein to be described;

Thence with the boundary of Carl Conrath Subdivision, with the following three (3) courses and distances;

- 1) S 57°46'15" W 406.83 feet to an iron pin set;
- 2) S 41°27'15" W 143.25 feet to an iron pin set;
- 3) S 17°40'15" E 118.57 feet to an iron pin set on the Northline of a parcel conveyed to Gary L. Rothwell, as recorded in O.R. Book 73, Page 937;

Thence, N 86°39'48" W 329.56 feet with the North line of said parcel conveyed to Rothwell, to an iron pin set;

Thence, S 04°01'28" W 615.44 feet with the West line of said parcel conveyed to Rothwell, and extending along the West line of a parcel conveyed to Sandra Whitmore, as recorded in O.R. Book 120, Page 179, to a stone found, and passing over a stone found at 373.93 feet;

Thence, S 84°22'57" E 200.00 feet with the South line of said 0.92 Acre parcel, to an axle found marking the Southwest corner of a parcel conveyed to Joy L. Cooper, ETAL, as recorded in OR. Book 504, Page 2573;

Thence with the boundary of said parcel conveyed to Joy L. Cooper, ETAL, with the following two (2) courses and distances:

- S 86°01'17" E 199.88 feet to a 5/8" o.d. iron pin found; 1)
- N 03°54'43" E 200.00 feet to a mag spike set in the centerline of Baker Road (Co.Road 10), and passing over an axle found at 170.55 feet;

Thence with the centerline of Baker Road, with the following three (3) courses and distances:

- N 85°57'20" E 70.47 feet to a point;
- N 77°51'31" E 109.31 feet to a point; 2)
- N 69°09'35" E 70.29 feet to a mag spike set on the West line of a parcel conveyed to Athens County Board of Commissioners, as recorded in O.R. Book 334, Page 683;

Thence leaving Baker Road with the boundary of said parcel conveyed to Athens County Board of Commissioners, with the following three (3) courses and distances:

- S 24°56'12" E 45.00 feet to an iron pin set;

- S 32°53'38" E 130.16 feet to a mag spike set in Radford Road marking the Northeast corner of a parcel conveyed to M. David L'Heureaux, as recorded in Book 419, Page 2437;

Thence with the boundary of said parcel conveyed to L'Heureaux, with the following two (2) courses and distances:

- 1) S 68°59'07" W 195.86 feet to an iron pin set;
- S 00°48'11" W 133.38 feet to an iron pin set;

Thence, S 57°46'15" W 226.68 feet continuing with the boundary of said parcel conveyed to L'Heuraux and extending along the West line of said parcel conveyed to Ramsey, to the PRINCIPLE PLACE OF BEGINNING, and containing 48.795 Acres, more or less, and is subject to all legal easements, right of ways, zoning ordinances, and restrictions of record.
