Thence, along the west-line of Sole (395-1953 O.R.)

S 35°20'12" W, 277.72 feet to an existing pin;

N 52°07'01" W,203.81 feet; to existing pin;

Thence, along the line of Mickunas (451-1098 O.R.)

N 38°46'42" E,294.14 feet to the point of beginning and containing 2.2552 acres.

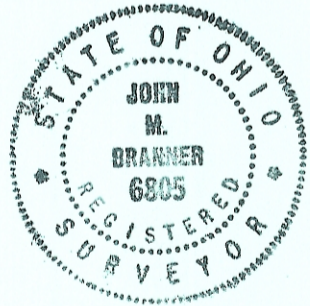

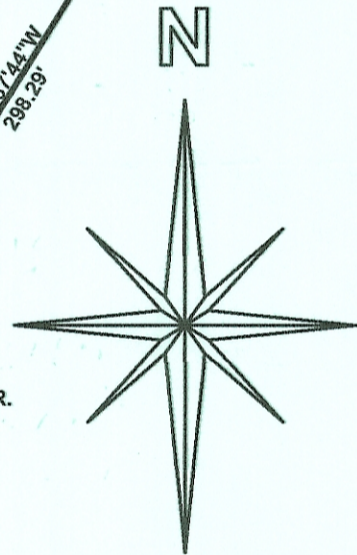
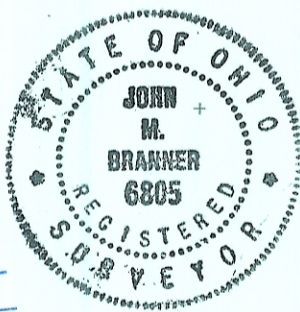
