DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-12, being a part of Continenal Resources Inc. OR.97 Pg.487, being part of Section 16 & Fractional Section 5, and more particularly described as follows:

(Tract 1) Beginning at a Stone found at the Northwest corner of Fractional Section 5; thence with the North line of said fraction North 89 Degrees 31 Minutes 52 Seconds East 289.74 feet to an iron pin set; thence leaving said line and into section 11 North 81 Degrees 46 Minutes 52 Seconds East 115.50 feet to an iron pin set; thence North 80 Degrees 46 minutes 52 Seconds East 341.22 feet to an iron pin set; thence North 27 Degrees 46 minutes 52 Seconds East 147.84 feet to a point in the centerline of Township Road 196, passing an iron pin set at 127.84 feet; thence with said centerline the following three courses to points: South 32 Degrees 48 minutes 47 Seconds East 81.32 feet; thence South 27 Degrees 00 minutes 09 Seconds East 81.38 feet; thence South 48 Degrees 53 minutes 37 Seconds East 84.70 feet to a point on the North line of Fractional Section 5; thence leaving said line and into Fractional Section 5 with the centerline of Township Road 196 the following eleven courses to points: thence South 51 Degrees 04 Minutes 16 Seconds East 113.53 feet; thence South 48 Degrees 08 Minutes 43 Seconds East 172.65 feet; thence South 30 Degrees 31 Minutes 53 Seconds East 53.48 feet; thence South 04 Degrees 31 Minutes 53 Seconds East 89.03 feet; thence South 23 Degrees 02 Minutes 55 Seconds East 68.12 feet; thence South 28 Degrees 20 minutes 29 Seconds East 115.14 feet; thence South 24 Degrees 44 Minutes 14 Seconds East 188.60 feet; thence South 15 Degrees 30 Minutes 51 Seconds East 206.47 feet; thence South 06 Degrees 29 Minutes 49 Seconds East 239.64 feet; thence South 01 Degrees 07 minutes 48 Seconds West 73.16 feet; thence South 07 Degrees 17 Minutes 32 Seconds East 156.04 feet; thence leaving said township road South 89 Degrees 50 minutes 40 Seconds West 2820.39 feet to an iron pin set at the Southwest corner of the Northeast Quarter of the Northeast Quarter of Section 16, passing iron pins set at 15.00 feet and on passing the West line of Fractional Section 5 at 1462.95 feet; thence North 00 Degrees 09 minutes 42 Seconds West 1317.80 feet to an iron pin set on the North line of Section 16; thence with said line North 89 Degrees 50 minutes 40 Seconds East 1357.44 feet to the place of beginning, containing 0.84 acres in section 11, 39.92 acres in fractional section 5 and 41.07 acres in Section 16 with a total of 81.81 acres, more or less, subject to all legal highways and easements.


