DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-12, being a part of Mark J. Howdyshell Trustee OR 203 Pg. 629, being part of Section 26, and more particularly described as follows:

(TRACT 20) Beginning at an iron pin found at the Southwest Corner of Fraction 32; thence South 74 Degrees 32 Minutes 32 Seconds East 451.65 feet to an iron pin found; thence South 74 Degrees 55 Minutes 30 Seconds East 636.10 feet to an iron pin found; thence South 74 Degrees 39 Minutes 18 Seconds East 652.64 feet to an iron pin found, passing an iron pin found at 398.49 feet; thence South 85 Degrees 44 Minutes 00 Seconds East 84.21 feet to an iron pin found and the place of beginning; thence South 85 Degrees 44 Minutes 00 Seconds East 346.99 feet to an iron pin found; thence South 38 Degrees 40 Minutes 30 Seconds West 1165.17 feet to a point in Federal Creek, passing iron pins set at 1031.23 feet and at 1112.23 feet and the centerline of State Route 329 at 1062.23 feet; thence along said creek North 38 Degrees 47 Minutes 33 Seconds West 190.45 feet to a point; thence leaving said creek North 32 Degrees 30 Minutes 03 Seconds East 933.17 feet to the place of beginning, passing iron pins set at 45.15 feet and at 105.15 feet and the centerline of State Route 329 at 75.15 feet, containing 5.76 acres, more or less, subject to all legal highways and easements.
