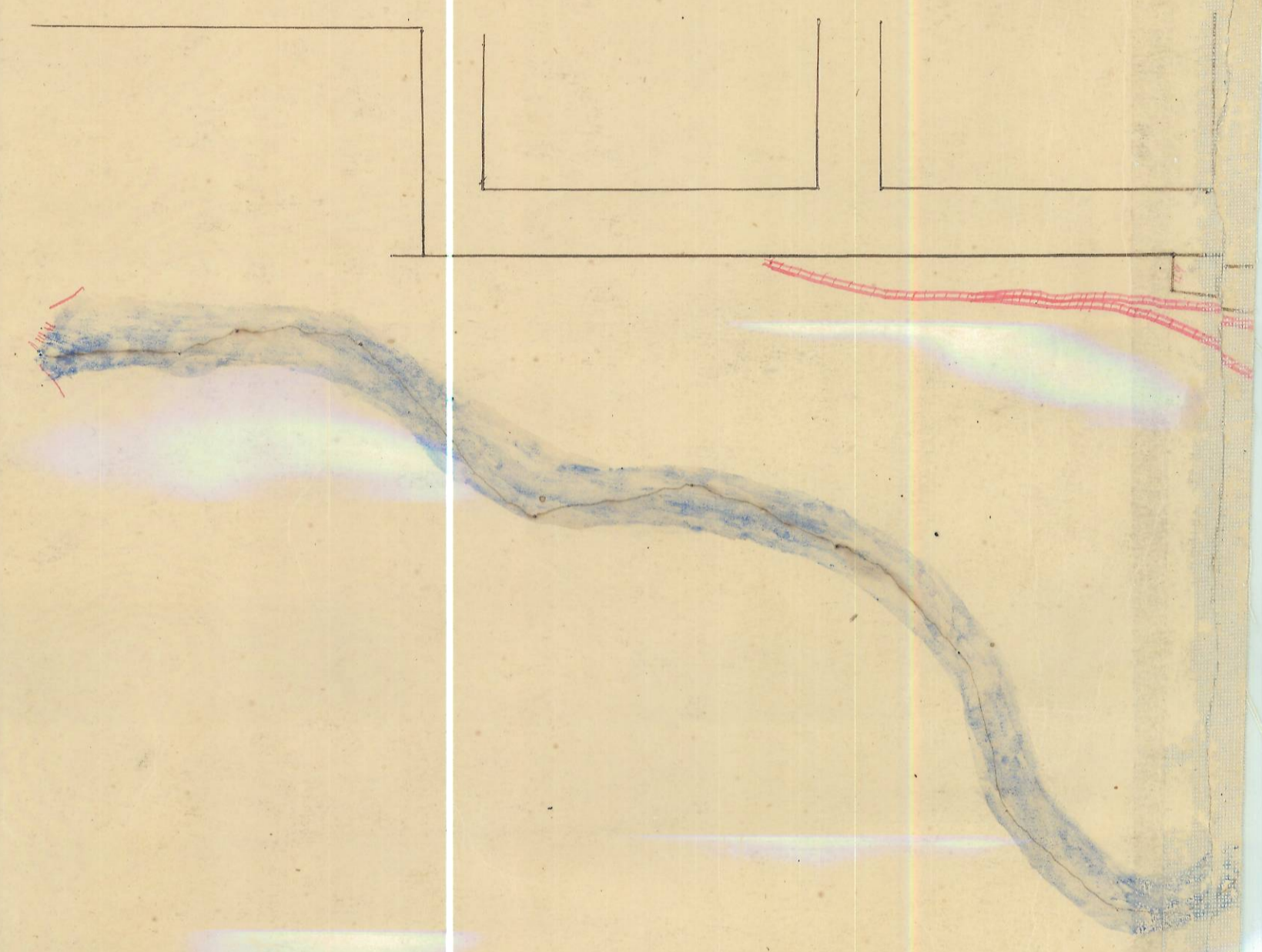


ENVELOPE: 105B

I hereby certify the above to be a correct plat of the Town of Buchtel, situate in Sections No. 6 & 12, Township No. 12, Range No. 15, Ohio Croupcays Purchase, Athens County, Ohio. Beginning at a point on the section line dividing said sections 6 & 12 and 41.34.63 chs. South of the North west corner of section six, thence East 7.10 chs. thence South 1.79 chs. thence S. 78 1/2 W. 1.415 chs. thence S. 72 W. 1.44 chs. thence S. 85 W. 1.42 chs. thence S. 87 1/4 W. 1.42 chs. thence N. 89 1/4 W. 1.42 chs. thence North 1.44 chs. to beginning, containing 1.58 acres, said tract contains five lots, as designated by the plat. The whole of the described tracts contains 37 1/2 acres, said tracts contain 156 lots, numbering from 1 to 156. The length, breadth and quantities they contain are written on them respectively, and all other distances, widths and alleys are written in links on the plat and a stone planted at the north west corner of lot No. 103, in said Town of Buchtel, given under my hand this 18th day of June 1884.
