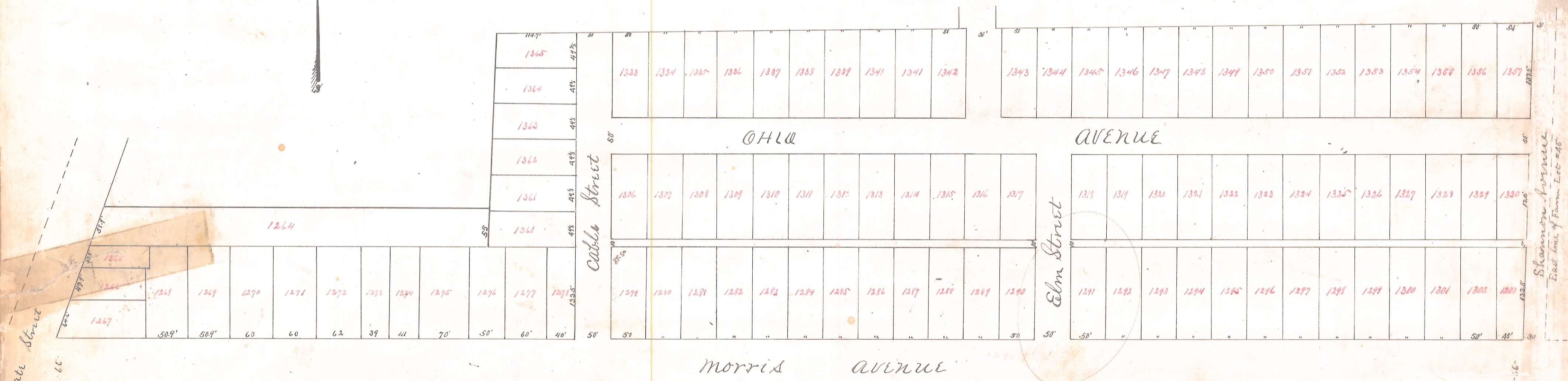
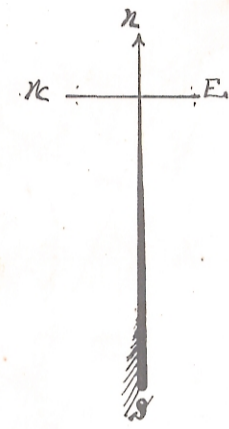


AMENDED PLAT OF CABLE HEIRS ADDITION TO ATHENS O.
