

To authorize annexation of certain territory to the Village of Coolville, Athens County, Ohio, as it obtained by the Council of the Village of Coolville, Athens County, Ohio.

Sec. 1. That the annexation of the following described territory situated in Troy Township, Athens County, Ohio, and in Town No. 5, Range No. 11, of the Ohio Company's Purchase, to-wit: - Beginning at the southeast corner of Fraction No. 32, and thence running west 43.50 chains to the southwest corner of said fraction; thence north, along the west line of said fraction, 40.70 chains to the middle of the county road; thence south 74° east, along the middle of said road, 20.82 chains to the middle of the county road; thence north 74° west, along the middle of said road, 447.9 feet; thence north 34 1/2° west, along the middle of said road, 511.8 feet; thence north 25 1/2° west, along the middle of said road, 713.4 feet; thence north 44 1/2° west, along the middle of said road, 131.5 feet to the north line of said fraction No. 32; thence east, along the north line of said fraction, 2303.4 feet to the southwest corner of fraction No. 18; thence north 32.75 chains to the northwest corner of said fraction No. 18; thence east along the north line of said fraction No. 18, 108 rods, more or less, to the middle of the Hocking River; thence down the middle of said river to the southeast corner of lands now owned by Anderson Bantz in fraction No. 36; thence south 81 1/2° west, along the south line of said Bantz' land, 12.47 chains to the east line of fraction No. 30; thence south, along the east line of said fraction No. 30, 19.67 chains to within 7.45 chains of the southeast corner of said fraction; thence west, parallel with the south line of said fraction No. 30, 22.80 chains; thence south, 7.36 chains to the south line of said fraction No. 30; thence west along the south line of said fraction, 15.00 chains to within 22.94 chains of the northwest corner of fraction No. 31; thence south 8.90 chains; thence south 66 1/2° west, 25.00 chains to the place of beginning (and including the territory now within the corporate limits) to the village of Coolville, Athens County, Ohio, as and the same is hereby authorized.

Sec. 2. That W. E. Peters, be and he hereby is authorized to prosecute the proceedings necessary to effect such annexation.

Sec. 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law. Passed this 2nd day of August, 1915.
