

Description of a 91.419 acre tract

Situated in Section 12, T.12, R.13, Canaan Township, and Section 7, T.9, R.13, Ames Township, Athens County, Ohio and being all of the First Tract and all of the residuals of the Second and Third Tract now in the name of the Lance Family Holdings L.L.C. and recorded in Volume 438, Page 736 of the Official Records of Athens County and being more particularly described as follows:

Beginning at a stone found at Grantor's North-east corner that bears North 87 degrees 29 minutes 48 seconds West, 1640.32 feet from a stone found at the North-east corner of Section 12, Canann Township.

S 87° 30′ 53″ E 1646.78 feet to the point of beginning and containing 91.419 Acres of which 0.91 acres are in Section 7, Ames Township and 90.509 acres are in Section 12 Canaan Township.

DESCRIPTION OF A 13.212 ACRE TRACT (EXCEPTION)
