Situated in Fraction 31, Section 21, Canaan Township, Athens County, Ohio and described as follows:

Commencing at a stone\* at the northwest corner of Fraction 31; thence along the north line of said Fraction 31 on an assumed bearing North 88°12'17" East 641.53 feet to an iron pin\* at the northeast corner of a 5.3714 acre tract described in Volume 32 Page 517 of the Athens County Deed Records; thence South 00°17'10" East 680.71 feet to an iron pin\*; thence South 54°37'41" West 59.17 feet to a found iron pin, THE TRUE POINT OF BEGINNING; thence on a random line South 17°52'55" East (passing a set iron pin at 101.06 feet) for a total distance of 117.88 feet to a point in the center of Athens County Road 90; thence along the said Athens County Road 90 South 80°47'17" West 53.30 feet to a point, the southeast corner of the aforesaid 5.3714 acre tract; thence along the east line of aforesaid 5.3714 acre tract North 07°44'37" East (passing found iron pins at 20.00 feet and 58.63 feet) for a total distance of 121.83 feet to the point of beginning containing 0.0713 acres and being part of a 9.66 acre tract described in Volume 353 Page 247 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


