Commencing at a stone found on the North line of Section 25, also being on the North line of a 19.4069 acre parcel conveyed to Mark W. Phillips, ETAL, as recorded in O.R. Volume 223, Page 457: said stone bears N 88°13'40" E 630.65 feet from a 1" o.d. iron pipe found marking the Northwest corner of the Northeast Quarter of Section 25;

Thence, S 02°20'05" E 20.00 feet with a line across said parcel conveyed to Phillips (O.R. Volume 223, Page 457), to a 1" o.d. iron pipe found marking the Northwest corner of said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), and being the **PRINCIPLE PLACE OF BEGINNING** of the **4.980 Acre** parcel herein to be described;

Thence, N 88°13'40" E 213.50 feet with the North line of said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), the same being the boundary of said parcel conveyed to Phillips (O.R. Volume 223, Page 457), to a railroad spike found in the centerline of North Coolville Ridge Road (Twp. Road No. 92) marking the Northeast corner of said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), and passing over a 1" o.d. iron pipe found at 198.50 feet;

Thence with the centerline of said North Coolville Ridge Road, the same being the East line of said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), with the following three (3) courses and distances:

Bearings of the above description are based on the North line of Section 25, as being N 88°13'40" E, and is an assumed Meridian used to denote angles only.



Commencing at a stone found on the North line of Section 25, also being on the North line of a 19.4069 acre parcel conveyed to Mark W. Phillips, ETAL, as recorded in O.R. Volume 223, Page 457: said stone bears N 88°13'40" E 630.65 feet from a 1" o.d. iron pipe found marking the Northwest corner of the Northeast Quarter of Section 25;

Thence, S 02°20'05" E 602.44 feet with a line across said parcel conveyed to Phillips (O.R. Volume 223, Page 457) and extending along the East boundary thereof to an iron pin set on the West line of said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), being the **PRINCIPLE PLACE OF BEGINNING** of the **4.980 Acre** parcel herein to be described, and passing over a 1" o.d. iron pipe found marking the Northwest corner of said parcel conveyed to Evans (O.R. Volume 274, Page 1047) at 20.00 feet;

Thence, N 89°14'00" E 487.54 feet with a line across said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), to a mag nail set in the centerline of North Coolville Ridge Road (Twp. Road No. 92) on the east line thereof, and passing over an iron pin set at 462.54 feet;

Thence with the centerline of said North Coolville Ridge Road, the same being the East line of said parcel conveyed to Evans of which this description is a part (O.R. Volume 274, Page 1047), with the following five (5) courses and distances:
