Situated in Fraction 34, Section 28, Town 5, Range 13, Canaan Township, Athens County, Ohio, and being more particularly described as follows:

Commencing at the Northeast corner of Fraction 34,

thence, following the North line of said Fraction, North 86 degrees 28 minutes 46 seconds West, a distance of 1534.82 feet to a point;

thence, leaving said Fraction line on a random line, South 3 degrees 31 minutes 31 minutes 16 seconds West, a distance of 110.21 feet to an iron pin found in the South line of East State Street Right-of-Way (old U. S. Route 50 East);

thence, following said Right-of-way, North 89 degrees 52 minutes 41 seconds East, a distance of 250.00 feet to an iron pin set in the South Right-of-way line of East State Street (old U.S. Route 50 East) at Station 955+63.45, 40.92 feet Right, said iron pin set being the POINT OF BEGINNING of the following described tract;

thence, following said Right-of-way, North 89 degrees 48 minutes 44 seconds East, a distance of 200.00 feet to an iron pin set at Station 957+63.45, 40.97 feet right;

thence, leaving said Right-of-way on a random line, South 0 degrees 10 minutes 53 seconds East, a distance of 435.00 feet to an iron pin set, passing an iron pin set at 50.00 feet;




