## TRACT 1

Situated in the southwest quarter of Section 31, Canaan Township, Town 5, Range 13, Athens County Ohio and descirbed as follows:

Commencing at an iron pin\* at the grantor's southeast corner, the southwest corner of Lot 39 of the Hickory Hills Subdivision on the north right of way line of Gura Road; thence on an assumed bearing along the grantor's east line and the west line of said Lot 39 North 08 Degrees 50 Minutes 00 Seconds East a distance of 80.92 feet to a set iron pin, THE TRUE POINT OF BEGINNING thence along a new line the following two bearings and distances: 1) North 79 Degrees 46 Minutes 55 Seconds West a distance of 344.91 feet to a set iron pin; thence 2) South 80 Degrees 59 Minutes 56 Seconds West, passing a set iron pin at 254.28 feet, for a total distance of 275.02 feet to a point in Athens County Road 98 on the grantor's west line; thence along said road and the grantor's west line the following two bearings and distances: 1) North 04 Degrees 53 Minutes 32 Seconds West a distance of 151.30 feet to a point ; thence 2) North 13 Degrees 29 Minutes 38 Seconds West a distance of 158.78 feet to a point at the grantor's northwest corner, the southwest corner of a 36.74 acre tract described in Volume 39 Page 94 of the Athens County Official Deed Records; thence along the grantor's north line and the south line of said 36.74 acre tract the following two bearings and distances: 1) North 89 Degrees 26 Minutes 00 Seconds East, passing an iron pin\* at 18.64 feet, for a total distance of 216.62 feet to an iron pin\*; thence 2) South 84 Degrees 27 Minutes 15 Seconds East a distance of 489.93 feet to a found iron pin at the grantor's northeast corner, the southeast corner of said 36.74 acre tract on the west line of aforesaid Lot 39 of the Gura Subdivision; thence along the grantor's east line and the west line of said Lot 39 South 08 Degrees 50 Minutes 00 Seconds West a distance of 281.43 feet to the POINT OF BEGINNING and containing 4.130 acres and being a part of a 7.924 acre tract described in Volume 265 Page 56 of the Athens County Official Deed Records.




