Situated in the southeast quarter of Section 33, Town 5, Range 13, Canaan Township, Athens County, Ohio and described as follows:

Commencing at a found cross notched stone at the southwest corner of the southeast quarter of said Section 33; thence along the south line of said Section 33 on an assumed bearing of North 89 degrees 27 minutes 58 seconds East (passing a found 5/8 inch iron pin at 40.1 feet) for a total distance of 262.15 feet to a point on the south line of Lot 3 of the Kathleen Smith Subdivision, THE TRUE POINT OF BEGINNING; thence along the south line of said Lot 3 North 80 degrees 48 minutes 05 seconds East, a distance of 143.13 feet to a set iron pin at the southeast corner of said Lot 3; thence along the east line of a 7.05 acre tract described in Volume 26 Page 201 of the Athens County Official Deed Records and the west line of a tract described in Volume 250 Page 627 of the Athens County Deed Records South 9 degrees 08 minutes 10 seconds East, a distance of 21.81 feet to a point (witness a found 5/8 inch rebar North 89 27'58" East 0.75 feet); thence along the south line of said Section 33 South 89 degrees 27 minutes 58 seconds West, a distance of 144.75 feet to the POINT OF BEGINNING and containing 0.036 acre, and being a part of a 68.63 acre tract described in Volume 362 Page 387 of the Athens County Deed Records. The above described 0.036 acre tract is to be continuous and contiguous with the remainder of the 68.63 acre tract described in Volume 362 Page 387 of the Athens County Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed Leonard F. Swoyer R.L.S. 6765.


