Commencing at the northwest corner of said Section 34; thence on an assumed bearing along a random line South 47 Degrees 19 Minutes 51 Seconds East for a distance of 3492.24 feet to a point in East State Street, THE TRUE POINT OF BEGINNING of this tract; thence in said East State Street along the grantor's north line, South 76 Degrees 23 Minutes 00 Seconds East for a distance of 243.87 feet to a point, the northeast corner of grantor's property; thence leaving said East State Street and along the grantor's east line for the following five bearings and distances: 1) South 05 Degrees 20 Minutes 04 Seconds West for a distance of 21.14 feet to a found iron pin; 2) thence South 04 Degrees 39 Minutes 00 Seconds West (passing a found iron pin at 58.69 feet) for a total distance of 65.71 feet to a set iron pin; 3) thence South 47 Degrees 19 Minutes 17 Seconds East for a distance of 68.91 feet to a set iron pin; 4) thence South 23 Degrees 34 Minutes 09 Seconds East for a distance of 318.50 feet to a found iron pin; 5) thence South 02 Degrees 28 Minutes 52 Seconds West (passing a found iron pin at 31.18 feet) for a total distance of 33.85 feet to a point in the center of the former railroad track, the southeast corner of grantor's property; thence along the center of the former railroad track, North 86 Degrees 15 Minutes 38 Seconds West for a distance of 452.84 feet to a set iron pin at the southwest corner of grantor's property; thence leaving the center of the former railroad track and along the west line of grantor's property, North 05 Degrees 21 Minutes 04 Seconds East (passing a found iron pin in the North railroad right of way line at 100.04 feet, passing a set iron pin at 327.73 feet and passing a found iron pin in the south right of way line of East State Street at 445.52 feet) for a total distance of



Commencing at the Northwest corner of said Section 34; thence on an assumed bearing along a random line South 47 Degrees 19 Minutes 51 Seconds East for a distance of 3492.24 feet to a point in East State Street; thence along said East State Street South 76 Degrees 23 Minutes 00 Seconds East for a distance of 243.87 feet to a point, THE TRUE POINT OF BEGINNING of this tract; thence continuing in said East State Street along the grantor's north line, South 76 Degrees 23 Minutes 00 Seconds East for a distance of 40.00 feet to a point; thence leaving said East State Street, along a new line, South 04 Degrees 39 Minutes 00 Seconds West (passing a concrete nail set in a 1" diameter drill hole at 22.99 feet and a set iron pin at 71.63 feet) for a total distance of 111.71 feet to a set iron pin in grantor's west line; thence along grantor's west line for the following three bearings and distances: 1) North 47 Degrees 19 Minutes 17 Seconds West for a distance of 50.48 feet to a set iron pin; 2) thence North 04 Degrees 39 Minutes 00 Seconds East (passing a found iron pin at 7.02 feet) for a total distance of 65.71 feet to found iron pin; 3) thence North 05 Degrees 20 Minutes 04 Seconds East for a distance of 21.14 feet to the POINT OF BEGINNING, containing 0.091 acres, being a portion of a 2.82 acre tract of land described in Volume 280, Page 500, Athens County Official Records.


