TRACT 2

Situated in Section 6, Town 5, Range 13, Canaan Township, Athens County, Ohio and described as follows:

Commencing at the southwest corner of said Section 6; thence along the north line of said Section 6 on an assumed bearing South 86 degrees 59 minutes 35 seconds East, a distance of 1649.00 feet to an iron pin* at the grantor's southwest corner; thence along the south line of the grantor and the north line of a 280.75 acre tract described in Volume 211 Page 355 of the Athens County Official Deed Records North 68 degrees 21 minutes 55 seconds East, a distance of 480.50 feet to a set iron pin, THE TRUE POINT OF BEGINNING; thence along an arbitrary line North 1 degrees 43 minutes 04 seconds East, passing a set iron pin at 573.69 feet, for a total distance of 585.65 feet to a point in Canaan Township Road 221 on the north line of the grantor; thence along said Canaan Township Road and the north line of the grantor the following five bearings and distances: 1) North 58 degrees 09 minutes 36 seconds East, a distance of 38.82 feet to a point; thence 2) North 66 degrees 26 minutes 33 seconds East, a distance of 71.33 feet to a point; thence 3) North 73 degrees 52 minutes 58 seconds East, a distance of 66.50 feet to a point; thence 4) North 79 degrees 39 minutes 53 seconds East, a distance of 154.67 feet to a point; thence 5) North 82 degrees 29 minutes 36 seconds East, a distance of 84.18 feet to a point; thence leaving said road and along an arbitrary line South 3 degrees 00 minutes 26 seconds West, passing a set iron pin at 12.96 feet, for a total distance of 538.77 feet to a set iron pin on the grantor's south line and the north line of aforesaid 280.75 acre tract; thence along the south line of the grantor and the north line of said 280.75 acre tract South 68 degrees 21 minutes 55 seconds West, a distance of 416.50 feet to the POINT OF BEGINNING and containing 5.130 acres, and being a part of a 20.743 acre tract described in Volume 206 Page 751 of the Athens County Official Deed Records. *denotes calculated location of monument based on a previous survey.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.

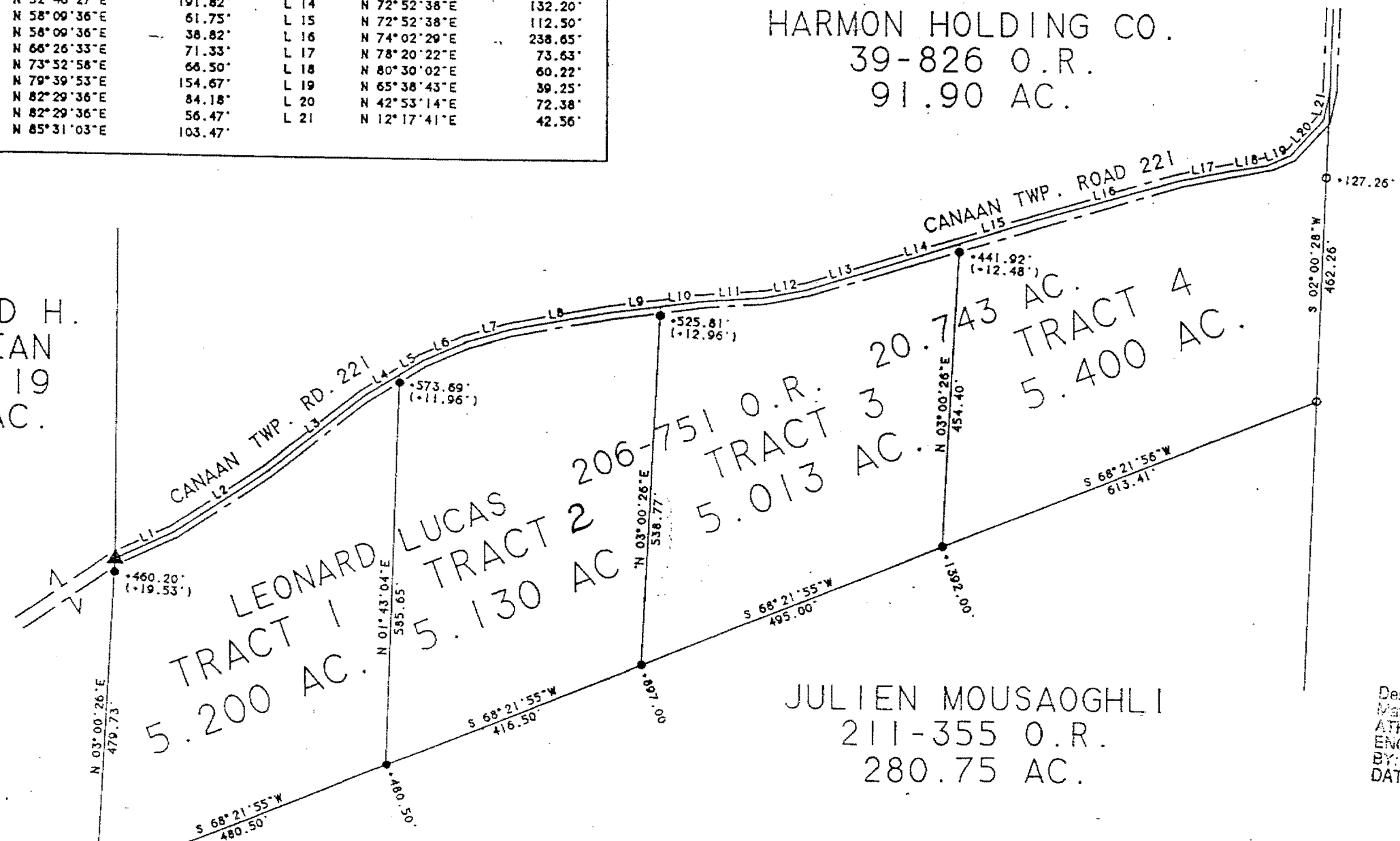

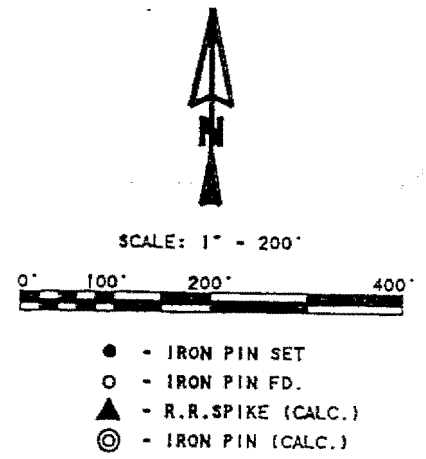

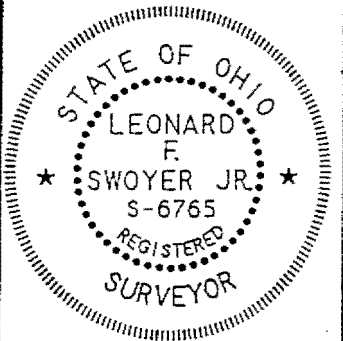
