Commencing at a found stone, the northeast corner of the west half of the west half of said Fraction 1; thence along the east line of the west half of the west half of said Fraction 1 South 01 degrees 21 minutes 02 seconds West 2228.02 feet to a found stone, the southeast corner of the west half of the west half of said Fraction 1; thence along the north property line of a 128.0 acre tract described in Volume 233 Page 578 of the Athens County Deed Records North 88 degrees 28 minutes 03 seconds West 119.49 feet to a set iron pin THE TRUE POINT OF BEGINNING: thence continuing along the north property line of said 128.0 acre tract North 88 degrees 28 minutes 03 seconds West 1189.23 feet to a set iron pin; thence North 36 degrees 23 minutes 16 seconds West 387.45 feet; thence North 56 degrees 55 minutes 07 seconds West 509.54 feet to a set iron pin; thence North 33 degrees 57 minutes 25 seconds East 334.73 feet to a set iron pin; thence North 06 degrees 36 minutes 28 seconds East 770.10 feet to a set iron pin; thence South 68 degrees 32 minutes 39 seconds East 919.42 feet to a set iron pin; thence South 28 degrees 16 minutes 21 seconds East 1508.05 feet to a set iron pin the point of beginning containing 40.000 acres and there being 25.35 acres in said Fraction 01 and 14.65 acres in said Fraction 31 and being part of two tracts described in Volume 355 Page 685 of the Athens County Deed Records.
