DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Carthage, T-5, R-12, being a part of George W. & Patricia K. Lewis Vol. 356 Pg. 661, being part of the Southeast Quarter of Section 34 and part of Fraction 34, and more particularly described as follows:

Beginning at an iron pin set at the Southwest Corner of Fraction 34; thence along the West line of Fraction 34 North 00 Degrees 00 Minutes 00 Seconds East 71.75 feet to an iron pin set; thence leaving Fraction 34 into Section 34 North 89 Degrees 39 Minutes 27 Seconds West 175.11 feet to an iron pin set; thence South 00 Degrees 42 Minutes 03 Seconds West 492.45 feet to an iron pin set; thence South 86 Degrees 50 Minutes 09 Seconds West 768.78 feet to a railroad spike set in the centerline of Co. Rd. 57; thence along said centerline the next 5 courses to masonary nails set: North 42 Degrees 18 Minutes 03 Seconds West 252.07 feet; thence North 34 Degrees 26 Minutes 04 Seconds West 200.36 feet; thence North 29 Degrees 07 Minutes 17 Seconds West 314.59 feet; thence North 25 Degrees 17 Minutes 04 Seconds West 544.89 feet; thence North 27 Degrees 52 Minutes 58 Seconds West 210.43 feet; thence leaving said centerline North 89 Degrees 17 Minutes 21 Seconds East 1716.05 feet to an iron pin set on the East line of Section 34; thence along said line South 00 Degrees 00 Minutes 00 Seconds West 245.67 feet to an iron pin set; thence leaving Section 34 into Fraction 34 North 89 Degrees 31 Minutes 22 Seconds East 798.24 feet to an iron pin set; thence South 00 Degrees 11 Minutes 21 Seconds West 620.50 feet to an iron pin set at a corner post; thence South 89 Degrees 38 Minutes 50 Seconds West 796.18 feet to the place of beginning, containing 11.34 acres in Fraction 34 & 39.09 acres in Section 34, being 50.43 acres total, more or less, subject to all legal highways and easements.
