Situated in Section 4 . Carthage Township, Town 5, Range 12, Athens County, Ohio and described as follows:

Commencing at the estimated northeast corner of Fraction 4 of Section 10 of Carthage Township; thence on an assumed bearing South 59 Degrees 13 Minutes 12 Seconds East a distance of 1572.18 feet to a found iron pin in Athens County Road 56 on the grantor's west line at the northeast corner of a 44.35 acre tract described in Volume 302 Page 608 of the Athens County Deed Records at the southeast corner of a 34.37 acre tract described in Volume 227 Page 717 of the Athens County Deed Records , THE TRUE POINT OF BEGINNING ; thence along said road and the east line of said 34.37 acre tract North 00 Degrees 00 Minutes 00 Seconds East a distance of 82.31 feet to a point ;thence leaving said road and along an arbitrary line North 89 Degrees 22 Minutes 36 Seconds East, passing a set iron pin at 20.19 feet, for a total distance of 1336.50 feet to a set iron pin ; thence along an arbitrary line South 00 Degrees 00 Minutes 00 Seconds East a distance of 220.00 feet to a set iron pin ; thence along an arbitrary line South 89 Degrees 22 Minutes 36 Seconds West, passing a set iron pin at 1319.50 feet, for a total distance of 1336.50 feet to a point in aforesaid Athens County Road 56 on the grantor's west line, on the east line of aforesaid 44.35 acre tract; thence along said road and the grantor's west line and the east line of said 44.35 acre tract North 00 Degrees 00 Minutes 00 Seconds East a distance of 137.69 feet to the POINT OF BEGINNING and containing 6.750 acres and being a part of the Third Tract of described in Volume 273 Page 554 of the Athens County Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed " L.F. SWOYER PS 6765."


