Description of survey for Joseph Rader

Being part of tracts of land transferred to Wanedia Rader as recorded in Official Records Volume 365 at page 401 Athens County Recorder's Office, Athens County, Ohio, also being a part of Section 5, Township-10, Range- 12, Carthage Township, Athens County, State of Ohio and more particularly described as follows;

Beginning for reference at an existing railroad spike being the northeast corner of said Section 5, T-10, R-12;

Thence along the assumed north line of said Section 5 North81°06'10"West, a distance of 797.85 feet to an existing iron pin being the northwest corner of a tract transferred to Julianna Sheridan as recorded in deed Book 358 at page 59, said iron pin being the principal point of beginning for the tract herein described;

Thence leaving said north line and along the boundary of said Sheridan tract South07°33'16"West, a distance of 799.27 feet to an existing iron pin;

Thence continuing with said boundary South82°23'06"East, passing thru an existing iron pin being the southwest corner of a tract transferred to James and Mary Spears as recorded in Deed Book 361 at page 249 at a distance of 348.19 feet and leaving said Sheridan boundary and continuing with said Spears boundary passing thru an existing iron pin at a distance of 525.94 feet and going a total distance of 556.97 feet to a point in the centerline of County Road 64, Mountain Belle Road:
