

Beginning for reference at a point in the center of Carthage Township Road No. 116, said point being N 00 E a distance of 585.97 feet from the southwest corner of Fraction No. 2; thence along or near the center of Township Road No. 116 S 71-31-46 W a distance of 50.72 feet to a point; thence S 86-38-48 W a distance of 320.63 feet to a point; thence N 81-20-33 W a distance of 65.05 feet to a point, said point being the **True Place of Beginning** for the parcel herein to be described; thence continuing near the centerline of Township Road No. 116 N 81-20-33 W a distance of 285.11 feet to a point; thence N 89-36-57 W a distance of 64.84 feet to a point; thence leaving Township Road No. 116 N 00 E a distance of 668.88 feet to an iron pin found, passing an iron pin found at 29.84 feet; thence N 89-39-32 E a distance of 346.70 feet to a 5/8-inch rebar set; thence S 00 W a distance of 714.30 feet to the **True Place of Beginning**, passing 5/8-inch rebar set at 586.86 feet and 698.35 feet distant, containing 5.4738, more or less, but subject to all legal easements, restrictions, and easements of record.




