DESCRIPTION OF SURVEY FOR LYLE SWAIN

Being a part of a tract of land transferred to Lyle Swain as recorded in Official Records Volume 195 at Page 389 Athens County Recorder's Office, Athens County Ohio, also being a part of the North Half of the Southwest Quarter of Section 16, Township-5-North, Range-12-West, Carthage Township, Athens County, State of Ohio and more particularly described as follows:

Beginning at an iron pin found on the North line of the North Half of the Southwest Quarter of said Section 16, Township-5, Range-12 from which an iron pipe found on the Northeast corner of the North Half of the Southwest Quarter bears South 82°14'15" East a distance of 1109.54 feet, said iron pin being the Northwest corner of an 11.00 acre± tract recorded in Official Records Volume 270 at Page 1708;

Thence leaving said North line and along the West line of said 11.00 acref tract South 03°54'05" West passing thru an existing iron pin at a distance of 1101.79 feet and going a total distance of 1131.08 feet to a point in the centerline of County Road #53 being the Southwest corner of said 11.00 acref tract;

Thence leaving said West line and along said centerline South 57°31'36" West a distance of 19.37 feet to a point;

Thence leaving said centerline North $23^{\circ}40'55"$ West passing thru a 5/8" iron pin set at a distance of 18.49 feet and going a total distance of 377.18 feet to a 5/8" iron pin set;

Thence North 09°07'27" East a distance of 272.16 feet to a 5/8" iron pin set;

Thence North 03°54'05" East a distance of 548.40 feet to a 5/8" iron pin set on the North line of the North Half of the Southwest Quarter;

Thence along said North line South 82°14'15" East a distance of 165.85 to the principal point of beginning containing 3.956 acres± subject to all legal easements and rights-of-way.

Bearings were derived from magnetic taken June 1, 1998.
