Situated in Section 23, Town 5, Range 12, Carthage Township, Athens County, Ohio and described as follows:

Commencing at an iron pin* at the southwest corner of Lot 1 of the White Pine Meadows Subdivision (envelope 529 A Athens County Recorder's Office), said found iron pin is THE TRUE POINT OF BEGINNING; thence South 10 degrees 31 minutes 51 seconds East, a distance of 50.00 feet to an iron pin* on the south side of a 50 foot private easement shown on the aforesaid White Pine Meadows Subdivision; thence along the west line of a 1.310 acre tract described in Volume 363 Page 1869 of the Athens County Official Records South 10 degrees 21 minutes 44 seconds West, a distance of 203.05 feet to an iron pin* at the southwest corner of said 1.310 acre tract; thence along the easterly right of way of U.S. Route 50 the following three courses and distances:

1. South 84 degrees 42 minutes 03 seconds West, a distance of 114.81 feet to a found 34" iron pin; thence 2. North 52 degrees 41 minutes 39 seconds West, a distance of 298.04 feet to a found 34" iron pin; thence 3. North 29 degrees 03 minutes 32 seconds West (passing a set iron pin at 203.17 feet) for a total distance of 430.64 feet to a point (witness a found 34 inch iron pin which bears North 29 degrees 03 minutes 32 seconds West 0.14 feet);

thence leaving the easterly right of way of said U.S. Route 50 and along the north line of the grantor and the south line of a 10.73 acre tract described in Volume 104 Page 836 of the Athens County Official Records North 79 degrees 26 minutes 48 seconds East (passing a found iron pin at 443.87 feet) for a total distance of 513.78 feet to an iron pin* at the northwest corner of the aforementioned Lot 1;

thence along the west line of the aforementioned Lot 1 South 11 degrees 56 minutes 39 seconds

East (passing a set iron pin at 201.02 feet) for a total distance of 400.32 feet to the point of
beginning and containing 5.5509 acres, and being all of the remaining property described in

Volume 281 Page 1239 of the Athens County Official Records.


