

Being a Survey of a part of a parcel conveyed to Ohio Rural Land, LLC, as recorded in O.R. Book 508, Page 373, in the Athens County Deed Records, and being part of Auditor's P.P.N. F01-0010061100, and further described as follows;

Commencing at an iron pin set on the West line of Carthage Township, the same being the East line of Lodi Township, also being the Northwest corner of the Southwest Quarter of Section 32 and said parcel conveyed to Ohio Rural Land, LLC (O.R.508,Pg.373) of which this description is a part, being on the East line of a 61.5 Acre parcel conveyed to Ohio Rural Land, LLC, as recorded in O.R. Book 508, Page 373, being the Southwest corner of a 60 Acre parcel conveyed to Warren J. Barnhill, Jr., ETAL, as recorded in O.R. Book 292, Page 1192;

Thence N 89°15′10″ E 555.32 feet with the North line of the Southwest Quarter of Section 32 and said parcel conveyed to Ohio Rural Land, LLC (O.R.508,Pg.373) of which this description is a part, the same being the South line of said parcel conveyed to Barnhill, ETAL (O.R.292,Pg.1192), to a mag nail set in the centerline of Barnhill Road (Twp. 
