Commencing at a point at the northeast corner of said Fraction 12; thence on an assumed bearing South 53 degrees 11 minutes 48 seconds West, a distance of 2265.83 feet to a point in Athens County Road 56 at the northeast corner of a 0.848 acre tract described in Volume 248 Page 790 of the Athens County Official Deed Records; thence leaving said road and along the north line of said 0.848 acre tract
North 60 degrees 15 minutes 32 seconds West, a distance of 194.38 feet
to a found iron pin at the northwest corner of said 0.848 acre tract, THE TRUE POINT OF BEGINNING; thence along the west line of said 0.848 acre tract South 76 degrees 00 minutes 59 seconds West, a distance of 177.16 feet to a found iron pin at the southwest corner of said 0.848 acre tract; thence along a new property line the following three bearings and distances: 1) North 10 degrees 56 minutes 46 seconds West, a distance of 106.44 feet to a set iron pin; thence 2) North 80 degrees 29 minutes 42 seconds East, a distance of 164.20 feet to a set iron pin; thence 3) South 18 degrees 45 minutes 46 seconds East, a distance of 93.80 feet to the POINT OF BEGINNING and containing 0.391 acre, and being a part of a 18.912 acre tract described in Volume 333 Page 819 of the Athens County Deed Records. THE ABOVE DESCRIBED 0.391 ACRE TRACT IS TO BE CONTINUOUS AND CONTIGUOUS WITH AN ADJOINING 0.848 ACRE TRACT DESCRIBED IN VOLUME 248 PAGE 790 OF THE ATHENS COUNTY OFFICIAL DEED RECORDS.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


