

Description of a 31.479 Acre Tract

Situated in Section 34, T.5, R.12, Carthage Township, Athens County, Ohio and being a part of the land as described in Volume 264, Page 947 of the Official Records of Athens County, Ohio and being more particularly described as follows:

Commencing at the Northwest corner of Section 34, thence S 54° 20' 42" E, 3220.40 feet to a point in the intersection of Township Road 57 (S. Rodehaver Road) and Township Road 107 (Young Road) and also being the **Point of Beginning** for the survey herein described:

Thence along Township Road 107 (Young Road) the following two courses:

- (1) N 81° 21' 22" E, 263.96 feet to a point;
- (2) N 77° 49' 09" E, 427.59 feet to a point;

Thence leaving said road and along the lines of National City Home Loan Services, LTD (551-782 O.R),

- (1) S 02° 03' 24" W, 726.88 feet to a stone found, passing an iron pin set by a fence post at 13.61 feet;
- (2) S 86° 58' 08" E, 653.50 feet to an iron pin set by a corner post;

Thence along the West line of Chivers (312-645 D.R.),

S 02° 50' 13" W, 1288.66 feet to an iron pin set;

Thence along the North line of Pierce (271-382 O.R.),

N 87° 31' 09" W, 351.23 feet to a point in Township Road 57 (S. Rodehaver Road), passing an iron pin found at 324.81 feet;

Thence along said road the following eleven courses:

- (1) N 28° 20' 19" W, 240.77 feet to a point;
- (2) N 24° 50' 53" W, 158.11 feet to a point;
- (3) N 13° 42' 32" W, 302.35 feet to a point;
- (4) N 22° 09' 59" W, 72.29 feet to a point;
- (5) N 38° 52' 23" W, 62.42 feet to a point;
- (6) N 52° 23' 49" W, 100.77 feet to a point;
- (7) N 55° 13' 01" W, 122.57 feet to a point;
- (8) N 49° 11' 18" W, 292.87 feet to a point;
- (9) N 32° 10' 01" W, 93.15 feet to a point;
- (10) N 15° 25' 54" W, 98.77 feet to a point;
- (11) N 08° 19' 34" W, 648.24 feet to the point of beginning and containing 31.479 acres, more or less

Subject to all easements and rights of way of record.
