DESCRIPTION OF A 7.651 ACRE TRACT

Situated in Section 34, T. 5, R. 12, Carthage Township, Athens County, Ohio and being a part of a 24.70 acre tract described in Volume 318 Page 471 and Volume 348 Page 53 Athens County Deed of Records and being more particularly described as follows.

Commencing at a found stone at the North-west corner of Section 34:

thence, South 7 degrees 03 minutes 41 seconds West, a distance of 533.87 feet to a point in Township Road 102, passing an iron pin found at 524.17 feet, said point being the POINT OF **BEGINNING:**

thence, following said Road, South 49 degrees 38 minutes 01 second East, a distance of 456.79 feet (429.00 feet Deed) to a point, passing a Rail Road Spike found at 421.72 feet;

+thence, South 64 degrees 14 minutes 21 seconds East, a distance of 170.11 feet (176.65 feet Deed) to a point in the intersection of Township Road 102, Township Road 103 and County Road 57; thence, leaving said Township Road 102 and Following Said Township Road 103, South 49 degrees 52 minutes 40 seconds West, a distance of 41.85 feet to a point; thence, South 36 degrees 15 minutes 09 seconds West, a distance of 122.37 feet to an iron pin found;

thence, South 37 degrees 12 minutes 00 seconds West, a distance of 111.67 feet to a point; thence, South 30 degrees 22 minutes 48 seconds West, a distance of 94.63 feet to a point; thence, South 4 degrees 26 minutes 30 seconds West, a distance of 96.54 feet to a point; thence, South 3 degrees 25 minutes 53 seconds East, a distance of 189.09 feet to a point; thence, leaving said Township Road 103, South 88 degrees 44 minutes 19 seconds West, a distance of 404.35 feet to an iron pin found, passing an iron pin found at 13.25 feet; thence, North 7 degrees 03 minutes 41 seconds East, a distance of 967.26 feet to the POINT OF BEGINNING, passing an iron pin set at 947.26 feet; said described tract containing 7.651 acres (333,270.8970 square feet).
