Commencing for reference at a stone found at the Northeast corner of Lease Lot 198 of Athens Township, Section 6; thence with the North line of said Lease Lot 198 and the South line of Dover Township, Section 1, North 87 degrees 20 minutes 52 seconds West a distance of 1804.52 feet to a 5/8" iron pin set, passing a 5/8" iron pin with 1-1/4" plastic ID cap stamped CANTER found at a distance of 1406.56 feet, a ½" iron pin found at a distance of 1642.12 feet, and being the point of **Beginning** of the tract of land to be described;

thence continuing with the North line of said Lease Lot 198 and the South line of said Section 1 North 87 degrees 20 minutes 52 seconds West a distance of 533.28 feet to a 5/8" iron pin set and passing a 5/8" iron pin with 1-1/4" plastic ID cap stamped CANTER found at a distance of 126.91 feet;

thence South 80 degrees 24 minutes 51 seconds East a distance of 220.00 feet to a ½" iron pin found;

thence South 23 degrees 43 minutes 16 seconds West a distance of 1.74 feet to the point of beginning, containing .761 acres more or less, and subject to the public easement of County Road 26, Township Road 635, and any other public or private easements of record.
