Situated in Fraction 4, Section 10, Town 10, Range 14, Dover Township, Athens County, Ohio described as follows:


Commencing at the southwest corner of Fraction 4; thence on an assumed bearing South 65 degrees 52 minutes 33 seconds East a calculated distance of 2,193.50 feet to a found iron pin the southwest corner of a 5.25 acre tract described in Volume 307 Page 25 of the Athens County Deed Records; thence along the south property line of said 5.25 acre tract and the northerly property line of a 25.68 acre tract described in Volume 362 Page 922 of the Athens County Deed Records South 73 degrees 20 minutes 09 seconds East 374.41 feet to a set iron pin THE TRUE POINT OF BEGINNING; thence North 17 degrees 28 minutes 00 seconds East 208.71 feet to a set iron pin; thence South 73 degrees 20 minutes 09 seconds East 208.73 feet to a set railroad spike in Athens County Road 28 (witness a found iron pin which bears North 17 degrees 28 minutes 00 seconds East 54.84 feet); thence along said road and the west property line of a 21.02 acre tract described in Volume 324 Page 385 of the Athens County Deed Records South 17 degrees 28 minutes 00 seconds West 208.71 feet to a found iron pin the southeast corner of aforesaid 5.25 acre tract; thence leaving said road and along the northerly property line of the aforementioned 25.68 acre tract and the south property line of aforementioned 5.25 acre tract North 73 degrees 20 minutes 09 seconds West (passing a found iron pin at 19.90 feet) for a total distance of 208.73 feet to the point of beginning containing 1.0000 acre and being part of a 5.25 acre tract described in Volume 307 Page 25 of the Athens County Deed Records.

Note: All set iron pins are 31 inches in length and 5/8 of an inch in diameter.
